ORDER NO. 69-10

AN ORDER adopting and promulgating revised Regulation I (Control of Air Pollution from Smoke, Visible Emissions and Suspended Particulate Matter), revised Regulation II (Control of Air Pollution from Outdoor Burning), Regulation V (Control of Air Pollution from Toxic Materials); providing that Regulation I and Regulation II supersede the corresponding regulations promulgated under Board Orders Nos. 67-1 and 68-1; directing the Executive Secretary to file a certified copy of this order and the regulations adopted hereby with the Secretary of State; and directing the Executive Secretary to send notice of this action by certified mail to every person heard or represented at the hearing on the proposed adoption of said regulations, or requesting such notice.

WHEREAS, pursuant to the requirements of Article 4477-5, Section 6(A), and Article 6252-13, V.T.C.S., the Texas Air Control Board duly published notice of a public hearing scheduled on May 27, 1969, for the purpose of considering the adoption of proposed revisions to Regulation I and Regulation II and proposed Regulation V on Control of Air Pollution from Toxic Materials; and duly circulated to interested persons in advance of the hearing notice of its intended action, which notices included copies of the proposed revisions to the then existing regulations and the proposed new regulation; and

WHEREAS, interested persons were invited to submit data, views and recommendations on the proposed revisions to the then existing regulations and on the proposed new regulation, either orally or in writing, at the hearing; and

WHEREAS, data, views and recommendations of interested persons were submitted to the Board at the hearing and were considered by the Board in adopting the revised regulations and new regulation appended hereto.

NOW, THEREFORE, BE IT ORDERED BY THE TEXAS AIR CONTROL BOARD:

1. The Board hereby approves, adopts and promulgates as regulations of the Board, the regulations appended to this Order, identified and entitled as follows:

- (a) Regulation I - Control of Air Pollution from Smoke, Visible Emissions and Suspended Particulate Matter.
- (b) Regulation II - Control of Air Pollution from Outdoor Burning.
- (c) Regulation V - Control of Air Pollution from Toxic Materials.

2. The Executive Secretary is directed forthwith to file a certified copy of this Order, together with the regulations promulgated hereby, with the Secretary of State for the State of Texas pursuant to Article 6252-13, V.T.C.S. Thirty days after their being filed with the Secretary of State, "Regulation I - Control of Air Pollution from Smoke, Visible Emissions and Suspended Particulate Matter" adopted by this Order shall supersede the corresponding regulation adopted and promulgated by Board Orders Nos. 67-1 and 68-1, and "Regulation II - Control of Air Pollution from Outdoor Burning" adopted by this Order shall supersede the corresponding regulation adopted and promulgated by Board Order No. 68-1.

3. The Executive Secretary is further directed to send notice of this action by certified mail to every person heard or

represented at the hearing on the proposed adoption of said re-  
vised regulations and new regulation, or requesting such notice.
