

## **Specialized Composting Training**

- Individuals managing or supervising a composting facility requiring an MSW registration or permit shall complete a TCEQ recognized or approved specialized compost training course before being issued a class 'A' or 'B' MSW Facility Supervisor license.
- Individuals completing the class 'A' or 'B' MSW facility supervisor course, passing the examination, but not completing the specialized course will be issued a provisional class 'A' or 'B' license. The completion of the specialized course must be before the expiration date of the provisional license.

The following training providers provide composting training meeting the requirements for the specialized training for the supervisors of registered or permitted composting sites. As more information is available on additional training, it will be posted on the TCEQ website.
