Subpart WWW Standards

- [§60.752\(a\)](#) Standard for MSW landfill with design capacity less than 2.5 million megagrams by mass or 2.5 million cubic meters by volume.
- [§60.752\(b\)](#) Standard for MSW landfill with design capacity equal to or greater than 2.5 million megagrams by mass or 2.5 million cubic meters by volume.
- [§60.752\(b\)\(2\)\(ii\)](#) Standard if the NMOC emission rate is equal to or greater than 50 megagrams per year.
