Drinking Water Quality Team Updates for DWA WG – 4/24/2013

- A letter regarding Version 15 of the Surface Water Monthly Operating Report (“SWMOR-Alt”) will soon be mailed to systems with Surface Water Treatment Plants that utilize membrane filtration systems. These plants must begin using the SWMOR-Alt to report their monthly data beginning July 1, 2013. This means the plant’s July 2013 SWMOR should be completed using the SWMOR-Alt form and will be due to TCEQ by August 10, 2013.
- With new staff members on board and gaining momentum, our efforts on certain rule programs are being reinvigorated. These include activities associated with chlorite, bromate, chlorine dioxide, total organic carbon, Consumer Confidence Reports, water quality parameters for the Lead and Copper Rule, and monitoring/reporting for chemical compliance.
- Reminder that 2012 Consumer Confidence Reports must be delivered to customers and TCEQ by July 1, 2013. We are working towards making an updated CCR generator available to water systems via our Drinking Water Watch website by mid-May 2013.

- Our efforts have increased in verifying eligibility requirements for reduced monitoring across Subchapter F rules. We continue to work on ensuring that processes are in place to efficiently identify public water systems eligible for reduced monitoring when applicable as well as verifying that systems meet the specific requirements for reduced monitoring.
- Systems that have exceeded the Operation Evaluation Level (OEL) associated with the Stage 2 Disinfection By-products Rule (DBP2) must submit an OEL report within 90 days of the exceedance. At this time, we recommend using the EPA's checklist found in the OEL guidance manual from 2008 (EPA 815-R-08-018). However, we have nearly completed a streamlined checklist that systems can use to complete their OEL report in the future.

### E2 Introduction

Currently the reporting of public drinking water laboratory analytical data to the Texas Commission on Environmental Quality (TCEQ) is submitted via hard copy, Microsoft Excel spreadsheets, and comma-separated value (CSV) files by the accredited laboratories and public water systems (PWS). To streamline the data submission process, TCEQ is developing a secure Web-based reporting system (called E2) for labs and PWS's to submit their data electronically. E2 will allow the submission of the following data types: Microbial; the Surface Water Monthly Operating Report; the Ground Water Rule Monthly Operating Report and the Disinfectant Level Report. E2 will process data in a manner that is compliant with EPA's Cross-Media Electronic Reporting Rule (CROMERR), which establishes requirements to assure that electronic documents are legally dependable. In order to accomplish CROMERR compliant end user authentication the system will integrate with TCEQ's State of Texas Environmental Electronic Reporting System (STEERS).

### **Water Utilities Status**

On **April 19, 2013**, there were **1,024** public water systems (PWSs) asking customers to follow outdoor water use restrictions. Of these systems, **655** are asking customers to follow a mandatory watering schedule and **369** are asking customers to follow a voluntary watering schedule. Seasonal forecasts continue to predict the drought to persist or intensify in many areas of the state. Increasing demands are resulting in more water systems implementing the water-rationing stages of their Drought Contingency Plans. The following is a list of the current **32** PWSs that have prohibited all outside watering:
