### **Job Description:**

Conducts technical environmental investigations, surveys, and complaint investigations; documents findings, prepares and reviews technical reports and provides advice and technical assistance. Conducts routine inspections, surveys, and follow-up investigations; prepares reports which document field activities and observed conditions. Conducts environmental monitoring; and prepares technical papers regarding studies involving environmental subjects. Provides technical assistance to the public, regulated community and other interested groups regarding the application of appropriate regulations. Assists with collecting and analyzing environmental samples.

### **Minimum Qualifications:**

A bachelor's degree from an accredited college or university (COPY OF OFFICIAL TRANSCRIPT REQUIRED WITH APPLICATION), with a major in a natural or physical science, engineering, environmental studies, or related field.

One year of full-time experience in the field of environmental activities directly related to the examples of work performed may be substituted for each year (30 semester hours) of the required education.

### **Preferred Requirements:**

Bachelor's or advanced degree from an accredited college or university with a major in chemistry.  
Experience performing source (stack) testing of emission sources.

### **Special Requirements:**

Moving up to 35 pounds of equipment/samples.  
Traveling up to 50% of the time.  
Wearing Air purifying respirator when necessary.  
Climbing to heights of 40 feet without acrophobia. Working more than 40 hours per week, as needed, to complete assignments, or to assist with emergency response efforts.

### **Condition of Employment:**

TCEQ will verify Selective Service registration for males born on or after January 1, 1960.
