### **Job Description:**

Performs technical work for the San Antonio Regional Office Air Program of the Texas Commission on Environmental Quality (TCEQ). Conducts investigations, surveys, and follow-up inspections; reviews collected data to prepare reports and to ensure compliance with rules and regulations; and makes recommendations of findings to include corrective action efforts. Participates in the regional emergency response rotation, and assists with emergency response efforts. Reviews technical reports associated with air regulation activities to ensure compliance with rules and regulations; makes recommendations to appropriate staff and management. Conducts environmental monitoring; and prepares technical papers regarding studies involving environmental subjects. Provides technical assistance to the public, regulated community, and other interested groups regarding the application of appropriate regulations. Assists with collecting and analyzing environmental samples.

### **Minimum Qualifications:**

A bachelor's degree from an accredited college or university (COPY OF OFFICIAL TRANSCRIPT REQUIRED WITH APPLICATION), with a major in a natural or physical science, engineering, environmental studies, or related field.

One year of full-time experience in the field of environmental activities directly related to the examples of work performed may be substituted for each year (30 semester hours) of the required education.

### **Preferred Requirements:**

Bachelor's degree from an accredited college or university with a degree in engineering, geoscience, basic or natural science, or environmental studies.

### **Special Requirements:**

Moving up to 35 pounds of equipment/samples.

Traveling up to 50% of the time.

Using sampling and protective equipment to conduct inspections.

Climbing to heights of 40 feet without acrophobia.

Working more than 40 hours as needed; and work on the regional emergency response rotation and assist with emergency response efforts.

The agency will review the applicant's driving history in connection with the use of a vehicle in the performance of the job.

**Condition of Employment:**

TCEQ will verify Selective Service registration for males born on or after January 1, 1960.
