This measure compares the percent change in volatile organic compounds and nitrogen oxides emitted in ozone non-attainment areas from point, area, on-road mobile, and non-road mobile sources. Year-end performance is higher than the target because of decreases in mobile emissions between 2011 and 2014 (due to more stringent emissions standards for newer vehicles entering the fleet). The year-end performance is due to a number of factors, including project changes and cancellations, and project completions before the last report submission. Some projects have not yet reported results. Further, there are projects on which the TERP staff (and Third-Party grantees) are working with the grant recipients to correct problems with either the reports or the use of grant-funded equipment. Explanation of Variance: Performance for the tons of nitrogen oxides (NOx) reduced through the Texas Emissions Reduction Plan (TERP) is below the target for the first quarter of FY 2016. This measure represents the amount of NOx projected to be reduced by the grant projects funded through the TERP Diesel Emissions Reduction Incentive (DERI) Program. No DERI grant contracts were executed this quarter. A new grant application period was opened November 3, 2015, with an application deadline of February 2, 2016. The grant selections are anticipated to be completed by April 2016, with contracts completed before the end of the fiscal year. Several large locomotive repower grants were carried forward from the FY 2015 grant application period and are in the process of being executed. The projected tons of NOx reduced from the locomotive projects will be included in the next quarterly report, while the NOx reductions from the projects awarded under the latest grant application period will be included in the fourth quarter report. We expect performance will meet or be above the target by fiscal year-end.

Explanation of Variance: Performance for tons of NOx reduced through the Texas Emission Reduction Plan (TERP) is below the target for the third quarter of FY 2016. This measure represents the amount of tons of NOx projected to be reduced by projects funded through the TERP Diesel Emissions Reduction Incentive (DERI) Program. Current performance is below the target for two main reasons. First, after the biennial projections were made, the program increased the cost per ton limits from \$10,000 to \$15,000, resulting in a higher average cost per ton. Second, marine and locomotive projects, which generally have a lower cost per ton, were excluded from the latest grant round in order to provide for funding of a greater number of on-road and non-road projects. The TERP program has awarded and executed contracts for \$12.4 million, with an additional \$48.6 million in grants selected for funding and are pending final contract execution. The additional projects, however, are expected to result in 4,990 tons of additional NOx reductions. The total reduction for the fiscal year is anticipated to be approximately 6,300 tons. Therefore, we do not expect to meet the target by the end of the fiscal year.
