## RECYCLING INDUSTRY COMMITTEE REPRESENTATIVE GROUPS

The Recycling Industry Committee (RIC) will be a diverse consortium of trade group representatives working with the Project Team and TCEQ to help with targeted outreach to increase survey participation among respondents in their professional networks. American Forest and Paper Association (AF&PA): AF&PA is the national trade association of the forest products industry and advances public policies that promote a strong and sustainable U.S. forest products industry in the global marketplace.
