

If your facility conducts all of the following:

1. Generates a characteristic (EPA Hazardous waste code starting with D) hazardous wastewater
2. Treats the wastewater in an exempt wastewater treatment unit
3. Has a discharge permit through the City
4. Through treatment generates a hazardous wastewater, Class 1 wastewater, or Class 2 wastewater
5. Immediately discharges the treated wastewater

Your facility does not report the wastewater on the AWS and does not report the treated wastewater on the NOR. Report the D listed wastewater on the NOR only.

If your facility conducts all of the following:

1. Generates a characteristic hazardous wastewater
2. Treats the wastewater in an exempt wastewater treatment unit
3. Does not have a discharge permit through the City
4. Through treatment generates a Class 2 wastewater
5. Immediately discharges the wastewater

Your facility does not report the wastewater on the AWS and does not report the treated wastewater on the NOR. Report the D listed wastewater on the NOR only.

If your facility conducts all of the following:

1. Generates a characteristic hazardous wastewater
2. Treats the wastewater in an exempt wastewater treatment unit
3. Does not have a discharge permit through the City
4. Through treatment generates a Class 1 wastewater¹ or hazardous wastewater²
5. Immediately discharges the wastewater

¹Your facility reports the Class 1 wastewater on the AWS, but does not report the Class 1 wastewater on the NOR. Report the D listed wastewater on the NOR.

²Your facility reports the treated hazardous wastewater on the AWS, but does not report the treated hazardous wastewater on the NOR. Report the D listed wastewater on the AWS and NOR.

If your facility conducts all of the following:

1. Generates a characteristic hazardous wastewater
2. Treats the wastewater in an exempt wastewater treatment unit
3. Generates a Class 2 wastewater through treatment
4. Has a discharge permit through the City
5. Stores the treated wastewater before discharging

Your facility does not report the wastewater on the AWS and does not report the treated wastewater on the NOR. Report the D listed wastewater on the NOR.

If your facility conducts all of the following:

1. Generates a characteristic hazardous wastewater
2. Treats the wastewater in an exempt wastewater treatment unit
3. Generates a Class 1 or hazardous wastewater through treatment
4. Has a discharge permit through the City
5. Stores the treated wastewater before discharging

¹Your facility reports the Class 1 wastewater on the AWS and the NOR. Report the D listed wastewater on the AWS and NOR.

²Your facility reports the treated hazardous wastewater on the AWS and the NOR. Report the D listed wastewater on the AWS and NOR.

If your facility conducts all of the following:

1. Generates a characteristic hazardous wastewater
2. Treats the wastewater in an exempt wastewater treatment unit
3. Generates a Class 2 wastewater from treatment
4. Ships the wastewater off-site

The facility does not report the hazardous or Class 2 waste on the AWS. The facility does not report the class 2 wastewater on the NOR. Report the hazardous wastewater on the NOR.

If your facility conducts all of the following:

1. Generates a characteristic hazardous wastewater
2. Treats the wastewater in an exempt wastewater treatment unit
3. Generates a Class 1 wastewater from treatment
4. Ships the wastewater off-site

The facility reports the Class 1 wastewater on the NOR and AWS. Report the hazardous wastewater on the AWS and NOR; however, the facility qualifies for a fee exemption on the AWS.
