(jointly, "Formosa" or "Applicant") letter of December 28, 2015 to Texas Commission on Environmental Quality (TCEQ) regarding protestant Texas Injured Workers' request for a hearing on Formosa's wastewater permit. Formosa's claim that "Protestants" have not shown that individual members of each Protestant group or association are "affected persons" in their own right is not correct. Texas Injured Workers is an organization of current and former workers from local petrochemical, gas, and oil industries on the Texas Gulf Coast who advocate for health and safety protections in the workplace and value the aesthetics and beauty of the bays as well as the recreational opportunities they afford. Members' livelihoods, health and safety, and recreational opportunities are affected

by Formosa's wastewater discharges. Injured Workers purpose includes pursuit of "whistleblowing" and research activities relating to Formosa's overall environmental record and maintaining a webpage devoted to their findings. Mr. Jurasek's love and enjoyment of Lavaca Bay as a recreational fisherman and as a local citizen who values the aesthetics and beautiful of the water both for himself and his grandchildren will be put at risk by Formosa's discharge. A memo from a group of the hourly employees implied that the company was rigging its pollution sampling -- by continuing to run pollutants to Lavaca Bay that is out of spec but "during sample days we run lower flows or shut down problem units to stay in spec." (Memorandum to Walter Chen through Shift Supervisor from hourly employees at Formosa Plastics). For the above reasons Ronnie Hamrick, Dale Jurasek, and Diane Wilson, members of Texas Injured Workers, should be "affected persons" with standing on Formosa's contested case hearing. A memo from a group of the hourly employees implied that the company was rigging its pollution sampling -- by continuing to run pollutants to Lavaca Bay that is out of spec but "during sample days we run lower flows or shut down problem units to stay in spec." (Memorandum to Walter Chen through Shift Supervisor from hourly employees at Formosa Plastics).

For the above reasons Ronnie Hamrick, Dale Jurasek, and Diane Wilson, members of Texas Injured Workers, should be "affected persons" with standing on Formosa's contested case hearing. Thank you very much.
