COMMENTS: I worked for the EPA for the State of Kentucky back in the lates 70's and early 80's. I know what a facility like this can cause for the surrounding area when it comes to air pollution. Just by looking at Pg 1 of the permit talking about the PPM's of substances such as ARSENIC, CADMIUM, MERCURY, THALLIUM, LEAD and Selinium should be enough of of a reason not to have this type of plant across the street from thousands of people in a residential area, and within 200 yards of public schools. Anytime you have

diesel fired heaters with sulfer and hydrogen sulfide outputs near homes and schools there is always going to be hazardous pollutants and the chance of dangerous accidents. Also along with the hydrocarbon output and petrochemical storage safety issues of a plant of this type in the middle of a very populated area, there is still the memory of the year long WOOD FIRE at this location that could not even be controlled or extinguished and covered our homes and the surrounding area with smoke and ash. It had to burn itself out, due to officials not being able to use chemicals or other materials which would have contaminated the wells and aquifer water.
