Item 1. Consideration of an application by MOTOROLA INC for a Class 2 Modification to hazardous waste Permit No. HW50281 in accordance with 31 TAC Section 305.69. Motorola operates a hazardous waste storage facility located approximately 1 mile south of Martin Luther King Blvd in Austin, Travis County, Texas. The facility stores wastes generated at the Ed Bluestein manufacturing facility and other Motorola Inc manufacturing plants.

Item 2. APPLICATION BY CHEMICAL RECLAMATION SERVICES, INC. for an amendment to Permit No. HW50084-001 to authorize continued operation and expansion of an industrial solid waste storage and processing facility for hazardous and non-hazardous wastes generated on site and from off-site sources. The facility is located on a 4.78 acre tract of land approximately 0.25 mile east of the intersection of State Highway 34 and State FM 55 on the northwest side of the private landfill road and approximately 0.5 mile north of Avalon in Ellis County, Texas.

Item 3. APPLICATION BY ISP TECHNOLOGIES, INC. (formerly GAF Chemicals Corporation) for an underground injection control permit (Proposed Permit No. WDW-299) to authorize the construction and operation of an additional hazardous waste disposal well at its Texas City plant. The proposed well will be used to dispose of hazardous wastewaters generated on-site during the manufacturing of acetylene based products. WDW-299 is to be approximately four miles north of La Marque at Highway 146 and Industrial Road, approximately 3,900 feet north and 900 feet east of the southwest corner of the John W. Little Survey, A-17, Galveston County, Texas.

APPLICATION BY U.S. ARMY/LONE STAR ARMY AMMUNITION PLANT for a permit (Proposed Permit No. HW-50292) to authorize the continued operation of an existing Class I hazardous industrial solid waste storage and processing facility. The facility is contiguous to the south side of U.S. Highway 82, twelve miles west of Texarkana and nine miles east of New Boston, in an unincorporated portion of Bowie County, Texas.

Item 5. APPLICATION BY JIM LINK dba Long Corral Dairy for a permit (Proposed Permit No. 03413) to authorize the disposal of waste and wastewater from a dairy which consists of a maximum of 650 milking head and a maximum of 550 heifers. The dairy is on the north side of an unnamed county road, approximately three and one half miles east of the intersection of Farm-to-Market

Road 3140 and State Highway 60 in Parmer County, Texas.

Item 6. APPLICATION BY NURI CORPORATION for a permit (Proposed Permit No. 03348) to authorize disposal of wastes and wastewater from a dairy. The dairy will consist of a maximum of 550 head. The dairy is located on the north side of Farm-to-Market Road 1870, approximately two and one half miles northwest of the intersection of Farm-to-Market Road 1870 and State Highway 11 in Hopkins County, Texas.

Item 7. APPLICATION BY U.S. DEPARTMENT OF ENERGY for a permit (Proposed Permit No. 03422) to authorize the disposal of treated domestic wastewater from a scientific research facility by irrigation on 1.8 acres of non-publicly accessible pastureland. The disposal volume is not to exceed 12,000 gallons per day average in the final phase. The permit also authorizes disposal of cooling tower blowdown and low volume building floor drain water by evaporation. The plant site, irrigation site and evaporation pond are on Hoyt Road, approximately 1000 feet north of the intersection of Farm-to-Market Road 1446 and Hoyt Road, approximately 4.5 miles west of the intersection of Interstate Highway 35E and Farm-to-Market 1446 in Ellis County, Texas.

Item 8. APPLICATION BY CITY OF EASTLAND for an amendment to Permit No. 10637-01 to authorize an increase in the discharge of treated domestic wastewater effluent from a volume not to exceed an average flow of 400,000 gallons per day to a volume not to exceed an average flow of 900,000 gallons per day. The wastewater treatment facilities are approximately one mile southeast of the intersection of State Highway 6 and U. S. Highway 80 and 1.4 miles northeast of the intersection of State Highway 6 and Interstate Highway 20, at the east end of Smith Street in the City of Eastland in Eastland County, Texas.

Item 9. APPLICATION BY CITY OF FRITCH for an amendment to Permit No. 10566-01 to authorize an increase in the disposal volume of treated domestic wastewater effluent from an average not to exceed 230,000 gallons per day to an average not to exceed 400,000 gallons per day. The treated wastewater is disposed of evaporation and by irrigation on 311.43 acres of rangeland. The wastewater treatment facility is located at the north end of Cornell Street in the City of Fritch, Hutchinson County, Texas. The facultative lagoon/oxidation ponds/irrigation sites are approximately one mile north of the intersection of State Highway 136 and Farm-to-Market Road 687 in Hutchinson County, Texas.

Item 10. APPLICATION BY HOUSTON LIGHTING AND POWER COMPANY for an amendment to Permit No. 01241 in order to add Outfall 101 to regulate the discharge of chemical metal cleaning waste and ash pond wastewaters. The permit currently authorizes the discharge of once through cooling water and previously

monitored wastewaters via Outfall 001 at a volume not to exceed an average flow of 1,616,000,000 gallons per day plus flow variable discharges of low volume wastewaters and treated sanitary wastewaters via Outfalls 002-006. The plant site is between Cedar Bayou and Trinity Bay approximately one mile east of the City of Baytown, Chambers County, Texas.

Item 11. APPLICATION BY U.S. DEPARTMENT OF THE ARMY for an amendment to Permit No. 02713 in order to route most of the treated wastewater discharged via Outfall 002 to an expanded treatment system where it will be discharged through Outfall 001. The proposed amendment would: (1) increase the discharge of treated wastewater via Outfall 001 from a volume not to exceed an average flow of 50,000 gallons per day to a volume not to exceed an average flow of 500,000 gallons per day; and (2) decrease the discharge of treated sewage effluent via Outfall 002 from a volume not to exceed an average flow of 35,000 gallons per day to a volume not to exceed an average flow of 900 gallons per day. The permit currently authorizes a discharge of treated wastewater from a water treatment plant via Outfall 003 to a volume not to exceed an average flow of 90,000 gallons per day, which will remain the same. The plant site is adjacent to Caddo Lake with the Town of Uncertain at the northern boundary and the Town of Karnack at the western boundary, Harrison County, Texas.

Item 12. CONSIDERATION OF a minor amendment to Permit No. 10408-07, issued to EL PASO WATER UTILITIES PUBLIC SERVICE BOARD in order to update the terms and format and to include a specific term of two years. The permit authorizes disposal of treated domestic wastewater effluent by well injection (in order to recharge the Hueco Bolson) and/or to a nearby power station for industrial reuse. The domestic wastewater is treated to drinking water standards prior to disposal. The disposal volume is not to exceed an average of 10,000,000 gallons per day. The plant site is approximately 1.2 miles east of U.S. Highway 54, 3 miles south of the intersection of U.S. Highway 54 and Farm-to-Market Road 2637. The injection well field is located 2 miles west of the plant site in El Paso County, Texas.

Item 13. APPLICATION BY CANUTILLO INDEPENDENT SCHOOL DISTRICT for renewal of Permit No. 11561-01 which authorizes a discharge of treated domestic wastewater effluent at a volume not to exceed an average flow of 50,000 gallons per day. The wastewater treatment facilities are located on the southeast corner of the high school campus, at the corner of Canutillo Street and 6th Street, in the City of Canutillo in El Paso County, Texas.

Item 14. APPLICATION BY CITY OF CUSHING for renewal of Permit No. 10437-01which authorizes a discharge of treated domestic wastewater effluent at a volume not to exceed an average flow of 81,000 gallons per day. The wastewater treatment facilities are approximately 200 feet south of the intersection of Fourth Street and Spruce Avenue in Nacogdoches

County, Texas.

Item 15. APPLICATION BY HUFFMEISTER 157, LTD. for renewal of Permit No. 13237-01 which authorizes a discharge of treated domestic wastewater effluent at a volume not to exceed an average flow of 5,000,000 gallons per day. The renewed permit would decrease the flow to 650,000 gallons per day average. The wastewater treatment facilities are along Little Cypress Creek, approximately 1600 feet west of Telge Road and 3000 feet north of Huffmeister Road in Harris County, Texas.

APPLICATION BY KLEIN INDEPENDENT SCHOOL DISTRICT for renewal of Permit No. 12224-01 which authorizes a discharge of treated domestic wastewater effluent at a volume not to exceed an average flow of 11,000 gallons per day. The wastewater treatment facilities are at the Klein I.S.D. Transportation Center, 2000 feet east and 2000 feet north of the intersection of Stuebner Airline Road and Spring Cypress Road in Harris County, Texas.

APPLICATION BY FRANK NEWTON for renewal of Permit No. 11249-01 which authorizes a discharge of treated domestic wastewater effluent at a volume not to exceed an average flow of 35,000 gallons per day. The wastewater treatment facilities are located about 1000 feet northeast of West Port Arthur Road and immediately west of Viterbo Road in Jefferson County, Texas.

The Dry Creek Wastewater Treatment Plant is located approximately 1.3 miles southeast of the intersection of Arch Davis Road and Lafayette Street in the southeast section of the City of Pittsburg in Camp County, Texas.

APPLICATION BY RICHMOND STEEL, INC. for renewal of Permit No. 02527 which authorizes a discharge of treated industrial wastewater and domestic sewage effluent at a volume not to exceed an average flow of 14,000 gallons per day from a structural steel erection, equipment rental and equipment cleaning facility. The renewed permit would delete the industrial wastestream and the provisions for the industrial wastewater. The renewed permit would also be assigned a municipal permit and assigned a new permit no., Permit No. 13568-01, since industrial wastewater will no longer be discharged. The wastewater treatment facilities are located approximately 1,000 feet south of the intersection of Little York Road and North Houston-Rosslyn Road in the City of Houston, Harris County, Texas.

The permit also authorizes flow variable discharges via Outfall 002 from Martin Lake; thence to Martin Creek; thence to the Sabine River in Segment No. 0505 of the Sabine River Basin. Outfall 003 regulates the intermittent, flow variable discharges from solid waste disposal areas. The Martin Lake Steam Electric Power Station is located adjacent to Martin lake, east of Farm to Market Road 2658 and approximately 5 miles southwest of the City of Tatum, Rusk-Panola Counties, Texas.
