1. APPLICATION BY FINA OIL AND CHEMICAL COMPANY for an amendment to Permit No. HW50140 in order to incorporate current rules and regulations and to update the permit consistent with current facility operations. Facility components consist of a land treatment demonstration (LTD) plot; container storage areas; Site H land treatment unit (LTU) authorized only for toxicity characteristic hazardous wastes; and closure and post-closure care of the Site E LTU. This facility manages both non-hazardous and hazardous industrial solid wastes generated on site. The facility is located on a 1167.91-acre tract of land five miles east of the Howard County Courthouse near the intersection of IH 20 and Refinery Road in the City of Big Spring, Howard County, Texas.

Item 2. APPLICATION BY GEORGIA GULF CORPORATION for an amendment to Permit No. 02067 to allow for the installation of a submerged diffuser servicing wastewaters discharged via Outfall 001. The proposed amendment would also increase the discharge of utility wastewaters from a volume not to exceed a flow of 300,000 gallons during any 24-hour period to a volume not to exceed a flow of 500,000 gallons during any 24-hour period via Outfall 005. The permit currently authorizes the discharge of: (1) treated sanitary wastewaters and utility wastewaters at a volume not to exceed 320,000 gallons during any 24-period via Outfall 001; (2) treated wastewaters at a volume not to exceed an average of 550,000 gallons per day via Outfall 004; and (3) stormwater via Outfalls 002, 003 and 006 at volumes variable with rainfall, will remain the same. The applicant operates an organic chemical manufacturing facility which produces Cumene, Phenol and Acetone as the major products. The plant site is at 3503 Pasadena Freeway in the City of Pasadena, Harris County, Texas.

Item 3. APPLICATION BY SOUTHWESTERN PUBLIC SERVICE COMPANY for an amendment to Permit No. 01312 to authorize an increase in the disposal volume of treated industrial wastewater effluent from an average of 940,000 gallons per day to an average of 2,100,000 gallons per day. The proposed amendment would also increase the amount of land to be used for irrigation from a total of 282 acres to 1040 acres of land. The treated industrial wastewater is disposed of by irrigation on companyowned property. The plant site is approximately two (2) miles east of the U.S. Highway 84/State Highway 331 intersection which is southeast of the City of Lubbock, Lubbock County, Texas.
