UNCONTESTED (New Hazardous Waste Permit)

- Item 1. Consideration of an application by BELL HELICOPTER TEXTRON, INC. for a new hazardous waste permit (Proposed Permit No. HW50282-001) to authorize storage of hazardous wastes generated during the manufacture, assembly, repair and test flight of helicopters. The permit will authorize operation of a 32,120-gallon capacity container storage area for storage of wastes generated on-site and off-site at other BHTI facilities. The wastes will be stored prior to being sent off-site to a permitted disposal facility. The hazardous waste management facility is to be on a 559-acre tract of land at 600 E. Hurst Blvd., Fort Worth, Tarrant County, Texas.

UNCONTESTED (Amendment to Hazardous Waste Permit)

- Item 2. Consideration of an application by UNITED STATES DEPARTMENT OF THE NAVY, NAVAL AIR STATION - Corpus Christi for an amendment to Permit No. HW50038 in order to remove a permitted 1000 gallon tank that has never been placed in service and to add two additional container storage units with a combined capacity of 120,700 gallons. The modified permit will authorize a total of three container storage units with a combined capacity of 137,900 gallons and impose the requirement that a RCRA Facility Investigation be performed on former solid waste management unit sites. The Corpus Christi Naval Air Station consists of approximately 2,050 acres of land on the north end of the Encinal Peninsula in the City of Corpus Christi, Nueces County, Texas.

UNCONTESTED (Class 2 Modification to Hazardous Waste Permit)

- Item 3. Consideration of an application by LAIDLAW ENVIRONMENTAL SERVICES (TES), INC. for a Class 2 Modification to Permit No. HW50225-001 in accordance with 31 TAC Section 305.69. The

permit modification authorizes: (1) the expansion of the emergency coordinator list; (2) updates to the facility evacuation routes; (3) updates and revisions to the Waste Analysis Plant; (4) the relocation of tanks; (5) reduction of overall tank capacity; and (6) reduction of overall facility air emissions. Laidlaw operates a Class I, hazardous and non-hazardous waste, and a Class II industrial solid waste storage, processing and transfer facility. The facility is located on a 12.5-acre tract of land on the east side of State Highway 134 (Battleground Road), approximately 700 feet from the intersection of State Highway 225 in La Porte, Harris County, Texas.

Item 4. Consideration of an application by QUANTUM CHEMICAL CORPORATION for a Class 2 Modification to Permit No. HW50231-000 in accordance with 31 TAC Section 305.69. The permit modification authorizes six additional wastes and an additional tank of 6839 gallons. The permit modification also updates the: Contingency Plan, Waste Analysis Plan, Closure Plan, Inspection Plan and the language of the permit and the application. Quantum Chemical operates a hazardous waste management facility located one mile north of the intersection of Miller Cut-off Road and State Highway 225 in Harris County, Texas.

UNCONTESTED (Class 3 Modification to Hazardous Waste Permit)

Item 5. Consideration of an application by SAFETY-KLEEN CORPORATION for a Class 3 Modification to Permit No. HW50232 in accordance with 31 TAC Section 305.69. The permit modification authorizes a new tank system to store spent anti-freeze. Safety-Kleen operates a commercial hazardous waste recycling center located at 1606 Missile Road in Wichita Falls, Wichita County, Texas.

UNCONTESTED (New Water Quality Permits)

Item 6. APPLICATION BY YME BOSMA DBA YME BOSMA DAIRY for a permit (Proposed Permit No. 03585) to authorize disposal of wastes and wastewater from a dairy. The dairy will consist of a maximum of 995 head. Washdown water, flushwater and stormwater will be retained in two (2) ponds. Wastewater from the ponds is to be disposed of by evaporation and/or irrigation on agricultural land. Manure and/or solids are to be applied as fertilizer on agricultural land. The dairy is on the north side of Farm-to-Market Road 1689, approximately 3 miles east of the intersection of Farm-to-Market Road 1689 and U.S. Highway 183 in Brown County, Texas.

Item 7. APPLICATION BY HATHEWAY PATTERSON CORPORATION for a permit (Proposed Permit No. 03572) to authorize a discharge of treated groundwater at a volume not to exceed an average flow of 14,400 gallons per day. The applicant proposes to operate a groundwater treatment unit from a site that formerly was a wood treatment facility and is presently under remediation and closure activities. The plant site is at 6809 Irvington Boulevard in the City of Houston, Harris County, Texas.

Item 8. APPLICATION BY LA JOYA INDEPENDENT SCHOOL DISTRICT for a permit (Proposed Permit No. 13663-01) to authorize disposal of treated domestic sewage effluent by subsurface absorption on seven drain fields with a minimum total absorption bed area of 41,760 square feet of land. The disposal volume is not to exceed an average of 15,000 gallons per day. Application rates for the absorption beds is not to exceed 0.36 gallons/square feet/day. The 8th Elementary School Wastewater Treatment Facility and subsurface disposal site are located on Farm-to-Market Road 492 (Doffing Road), approximately 3000 feet south of the intersection of Farm-to-Market Road 676 and Farm-to-Market Road 492 in Hidalgo County, Texas.

Item 9. APPLICATION BY CITY OF NEW LONDON for a permit (Proposed Permit No. 12376-02) to authorize a discharge of treated domestic wastewater effluent at a volume not to exceed an average flow of 20,000 gallons per day. The wastewater treatment facility will serve the residents of Sexton City. The Sexton City Wastewater Treatment Facilities are one mile southeast of the intersection of State Highway 42 and Farm-to-Market Road 918 in Rusk County, Texas.

UNCONTESTED (Amendment to Water Quality Permits)

Item 10. APPLICATION BY CINCO MUNICIPAL UTILITY DISTRICT NO. 1 for an amendment to Permit No. 13558-01 to authorize an increase in the discharge of treated domestic wastewater effluent from a volume not to exceed an average flow of 1,080,000 gallons per day to a volume not to exceed an average flow of 1,690,000 gallons per day. The proposed amendment would also authorize a variance to the buffer zone requirements. The wastewater treatment facilities are approximately 3.25 miles east and 2.0 miles north of the intersection of Farm-to-Market Road 723 and Farm-to-Market Road 1093 in Fort Bend County, Texas.

Item 11. APPLICATION BY CITY OF HOUSTON for an amendment to Permit No.

10495-111 in order to add an additional outfall and decrease the flow. The permit currently authorizes a discharge of treated domestic wastewater effluent at a volume not to exceed an average flow of 19,700,000 gallons per day via Outfall 001. The proposed amendment would authorize a discharge of treated domestic wastewater effluent at a volume not to exceed an average combined flow of 13,340,000 gallons per day via Outfalls 001 and 002. The Beltway Wastewater Treatment Facilities are approximately 1700 feet north of Bellaire Boulevard and 3400 feet west of Roark Road in the City of Houston in Harris County, Texas.

Item 12. APPLICATION BY NORTHWESTERN RESOURCES CO. for an amendment to Permit No. 02653 to authorize the discharge of treated domestic wastewater to pond 004. The current permit authorizes intermittent flow variable discharges of treated domestic sewage, mine water, dewatering wells groundwater and surface water runoff, which will remain the same. The applicant operates the Jewett Lignite Surface Mine. The plant site is approximately six miles north of the City of Jewett in Leon, Limestone and Freestone County, Texas.

Item 13. APPLICATION BY CITY OF PRESIDIO for an amendment to Permit No. 12955-01 to authorize an increase in the disposal volume of treated domestic wastewater effluent from 340,000 gallons per day average to 680,000 gallons per day average. The wastewater is disposed of by evaporation and irrigation on 200 acres of coastal bermuda grass and alfalfa. Application rates for the irrigated land shall not exceed 4.9 acre-feet/acre/year. The wastewater treatment facility, evaporation and irrigation site are approximately two miles northwest of the northern intersection of U.S. Highway 67 and Farm-to-Market Road 170 in Presidio County, Texas.

Item 14. APPLICATION BY CITY OF SWEENEY for an amendment to Permit No. 10297-01 to authorize an increase in the discharge of treated domestic wastewater effluent from a volume not to exceed an average flow of 840,000 gallons per day to a volume not to exceed an average flow of 975,000 gallons per day. The wastewater treatment facilities are approximately three miles southeast of the intersection of State Highway 35 and Farm-to-Market Road 1459, approximately two miles northeast of Sweeny on the west bank of the San Bernard River in Brazoria County, Texas.

Item 15. APPLICATION BY THE DOW CHEMICAL COMPANY for an amendment to Permit No. 01866 to authorize an increase in the discharge of chemical plant wastewaters via Outfall 001 from a volume not to exceed an average flow of 3,230,000 gallons per day to a volume not to exceed an average flow of 4,800,000 gallons per

day. The proposed amendment would also change the provisions regarding the discharge of stormwater to include utility wastewaters from process Unit VI via Outfall 003. The permit authorizes an intermittent flow variable discharge via Outfall 003. The permit currently authorizes: a discharge of refinery wastewaters at a volume not to exceed an average flow of 3,300,000 gallons per day via Outfall 002; and an intermittent flow variable discharge of stormwater runoff via Outfall 004, which will remain the same. The plant site is in the southwest quadrant defined by the intersection of State Highway 332 with FM Road 523 north of the City of Freeport, Brazoria County, Texas.

REMANDED TO OFFICE OF HEARINGS EXAMINERS

Item 16. APPLICATION BY WEST TEXAS UTILITIES COMPANY for an amendment to Permit No. 01152 in order to add three (3) internal stormwater outfalls (Outfalls 201, 301, and 401) at intermittent flow variable discharges. The permit currently authorizes a discharge of once through cooling water and previously monitored effluents at a volume not to exceed an average flow of 131,400,000 gallons per day via Outfall 001, which will remain the same. The applicant operates the San Angelo Steam Electric Station. The plant site is at 6465 Knickerbocker Road in the City of San Angelo, Tom Green County, Texas.

UNCONTESTED (Minor Amendments to Water Quality Permits)

Item 17. CONSIDERATION OF A STAFF INITIATED A MINOR AMENDMENT TO Permit No. 01984, ISSUED TO CHANNEL TERMINAL CORPORATION AND STEMIL, INC., dba Intercontinental Terminals Company, in order to include whole effluent toxicity limits at Outfall 002. The permit currently authorizes intermittent flow variable discharges of stormwater from tank farm areas via Outfalls 001, 003, 004, 005, and 006; a discharge of treated industrial wastewater at a volume not to exceed an average flow of 273,000 gallons per day via Outfall 002; and a discharge of treated ballast water at a volume not to exceed an average flow of 50,000 gallons per day via Outfall 007, which will remain the same. The applicant currently operates a bulk liquids storage terminal and commercial wastewater treatment facility. The plant site is at 2627 Tidal Road in the City of Deer Park, Harris County, Texas.

Item 18. APPLICATION BY CITY OF FROST for a minor amendment to Permit No. 10444-01 for authorization to replace the existing Imhoff tank/stabilization pond system with an extended aeration activated sludge facility. The permit currently authorizes a discharge of treated domestic wastewater effluent at a volume not to exceed an average flow of 40,000 gallons per day, which will remain the same. The wastewater treatment plant is approximately 0.40 mile northwest of the intersection of State

Highway 22 and Farm-to-Market Road 667 in Navarro County, Texas.

Item 19. CONSIDERATION OF STAFF INITIATED MINOR AMENDMENT TO Permit No. 13006-01, issued to LAMAR CONSOLIDATED INDEPENDENT SCHOOL DISTRICT, in order to provide less restrictive requirements for sludge disposal testing and reporting. The permit authorizes a discharge of treated domestic wastewater effluent at a volume not to exceed an average flow of 17,000 gallons per day from the Meyer Road Intermediate School No. 4 Wastewater Treatment Plant. The plant site is approximately 3.5 miles generally south of the City of Rosenberg and approximately 1300 feet east of the intersection of J. Meyer Road and State Highway 36 in Fort Bend County, Texas.

Item 20. CONSIDERATION OF STAFF INITIATED MINOR AMENDMENT TO Permit No. 13007-01, issued to LAMAR CONSOLIDATED INDEPENDENT SCHOOL DISTRICT, in order to provide less restrictive requirements for sludge disposal testing and reporting. The permit authorizes a discharge of treated domestic wastewater effluent at a volume not to exceed an average flow of 17,000 gallons per day from the Manford Williams Elementary No. 8 Wastewater Treatment Plant. The plant site is at 5111 Farm-to-Market Road 762, approximately 4.5 miles east-southeast of the City of Rosenberg in Fort Bend County, Texas.

Item 21. APPLICATION BY CITY OF SEAGOVILLE for a minor amendment to Permit No. 10370-01 is authorized to compost sludge on-site, and to distribute and market the compost. The permit currently authorizes a discharge of treated domestic wastewater effluent at a volume not to exceed an average flow of 1,200,000 gallons per day from the Seagoville Wastewater Treatment Plant, which will remain the same. The plant site is approximately 0.65 of a mile northeast of the intersection of Malloy Bridge Road and U.S. Highway 175, and approximately 0.5 of a mile north of U.S. Highway 175, in Dallas County, Texas.

UNCONTESTED (Renewal of Water Quality Permits)

Item 22. APPLICATION BY BELL COUNTY WATER CONTROL AND IMPROVEMENT DISTRICT NO. 1 for renewal of Permit No. 10351-02 which authorizes a discharge of treated domestic wastewater effluent at a final volume not to exceed an average flow of 15,000,000 gallons per day from the Main Wastewater Treatment Facilities. The plant site is approximately 0.75 miles north of the intersection of Farm-to-Market Road 2410 and U.S. Highway 190, adjacent to and west of Farm-to-Market Road 2410

in the City of Killeen in Bell County, Texas.

Item 23. APPLICATION BY CHAMP'S WATER COMPANY for renewal of Permit No. 11005-01 which authorizes a discharge of treated domestic wastewater effluent at a volume not to exceed an average flow of 280,000 gallons per day. The West Montgomery Wastewater Treatment Plant is southwest of the intersection of Bonazzi Boulevard and Stallings Drive, approximately 3,750 feet west of West Montgomery Road, 11 miles northwest of the City of Houston central business district and 2.9 miles west of Interstate Highway 45 in Harris County, Texas.

Item 24. APPLICATION BY FUMICO, INC. for renewal of Permit No. 02450 which authorizes disposal of treated wastewaters by recycling and then by irrigation on a 0.75 acre tract of land.
