The amendments also reorganize and modify existing portions of the Chapter 117 rules which apply to sources of NOx in the Beaumont/Port Arthur and Dallas/Fort Worth ozone nonattainment areas, as well as to electric generating facilities located in Palo Pinto County and 31 attainment counties of east and central Texas, in order to improve implementation of the existing Chapter 117. In addition, the proposed amendments add carbon monoxide (CO) and ammonia emission specifications for electric generating facilities located in 31 attainment counties of east and central Texas. However, the commission is excluding the proposed new Sections 117.151 and 117.481, and the proposed amended Sections 117.135(2) and 117.475(i) from the SIP in order to simplify the approval process for alternative CO or ammonia emission specifications, thereby eliminating the need for case-specific SIP revisions by the EPA to complete the of an alternate CO or ammonia limit.
