Admin. Code chs. 80, 305, and 330, Tex. Health & Safety Code ch. 361, and the rules of the Texas Commission on Environmental Quality. The Commission will also consider timely public comments and the Executive Director's Response to Comments, the record, timely related filings, exceptions and replies. (Anthony Tatu, Matthew Unenenwu)

Adopt the ALJ's Proposed Order as revised by the ALJ's letter dated November 7, 2011 with the following changes: A) Add a new Ordering Provision which reads: "The Commission adopts the Executive Director's Response to Public Comments in accordance with 30 TAC Sections 50.117 and 80.126. Also in accordance with Section 50.117, the Commission issues this Order and the attached Permit, Exhibit A, as its single decision on the permit application. Information in the agency's record of this matter, which includes evidence admitted at the hearing and part of the evidentiary record, document the Executive Director's review of the permit application, including that part not subject to a contested case hearing, and establishes that the terms of the attached

permit are appropriate and satisfy all applicable federal and state requirements." B) Modify the ALJ's Special Condition G relating to the removal of citizens recycling center by replacing the phrase: "through a minor permit amendment" with the phrase: "through a future application"; C) Delete the ALJ's Special Conditions B, C, D, and F, as set forth in his November 7, 2011 letter. Special Conditions B, C, and D relate to provision of potable water and domestic wastewater service for the site, which are not governed by the municipal solid waste permit issued in this contested case matter. TCEQ rules applicable to contaminated water management, specifically 30 TAC Sections 330.207 and 330.63(b)(4), are not intended to address the provision of domestic wastewater service at a municipal solid waste facility, but rather are meant to govern the disposal of water that has come into contact with municipal solid waste. In addition, since the TCEQ lacks specific jurisdiction to ban the use of certain off-site roadways, Special Condition F is unenforceable as a condition in an MSW permit. D) Approve issuance of the Executive Director's draft permit with the ALJ's proposed changes except for those deleted in this motion; and E) Adopt the Executive Director's Response to Comments. BS/BG; all agree.

located that is or previously was subject to an exemption under this section. (Timothy Reidy, Chance Goodin)

Adopt the proposed Resolution appointing six individuals to the Tax Relief for Pollution Control Property Advisory Committee and appoint the following individuals to serve for 4 year terms: Greg Maxim, as an industry representative; Michael Nasi, as an industry representative; Paul Coons, as an industry representative; Donald Lee, as a taxing unit representative; Cyrus Reed, as an environmental group representative; and Lloyd Graham, as a school district or junior college district representative. CR/BG; all agree.

The Emergency Order grants LCRA's request to temporarily change the process required in its 2010 Water Management Plan for curtailment of interruptible stored water. LCRA has the right to divert and use up to 1.5 million acre feet (MAF) from Lakes Buchanan and Travis, in Travis, Llano, and Burnet Counties, Texas, under Certificates of Adjudication Nos. 14-5478 and 14-5482. These certificates require LCRA to develop the Water Management Plan (WMP), Permit No. 5838, which provides how LCRA makes water available from these lakes to help meet "firm" water customer needs, downstream interruptible irrigation demands, and environmental flow needs of Matagorda Bay and the lower Colorado River. The Water Management Plan also provides how LCRA will manage and curtail supplies from the lakes during times of drought including through a repeat of the Drought of Record. LCRA requests an emergency order to change the triggers for curtailment of interruptible water by providing that on March 1, 2012, if combined storage is: (1) below 850,000 acre feet, LCRA will provide no interruptible water for its Gulf Coast and Lakeside operations, (2) at or above 850,000 and less than 920,000 acre feet, LCRA will provide no more than 125,000 acre feet to its Gulf Coast, Lakeside, Garwood and Pierce Ranch operations, and (3) at or above 920,000 acre feet, LCRA will provide interruptible stored water in accordance with the current Water Management

Plan. LCRA also requests approval to provide a second crop only upon a determination by the LCRA Board that sufficient water is available, and to provide interruptible stored water to Garwood and Pierce Ranch customers in accordance with its contracts. (Robin Smith, Kathy Alexander)

Affirm the Emergency Order issued by the Executive Director on November 17, 2011 which granted the Lower Colorado River Authority to amend its 2010 Water Management Plan, Permit No. 5838. CR/BG; all agree.

This Water Curtailment Plan is required to be prepared before LCRA implements mandatory firm water customer curtailment under Tex. Water Code § 11.039. LCRA's Water Management Plan also requires that this plan be approved by the LCRA Board and the Commission. The Executive Director has found that the plan meets the requirements of Texas Water Code § 11.039 and 30 Tex. Admin. Code Chapter 288. (Robin Smith, Kathy Alexander)

Approve the Lower Colorado River Authority's Water Curtailment Plan for its firm water customers, as recommended by the Executive Director. BG/CR; all agree.

The proposed rulemaking would establish requirements at the licensed low-level radioactive compact waste disposal facility for the disposal of party state compact waste that has been commingled with waste from other sources at a commercial waste processing facility. The proposed rulemaking would also add definitions and prohibit the receipt and disposal of waste of international origin. (Don Redmond, Hans Weger) (Rule Project No. 2011-036-336-WS)

The adopted rules implement Federal Clean Air Act reasonably available control technology requirements for sources of VOC emissions per the control technique guidelines published by the United States Environmental Protection Agency. The adopted rules affect the following eight emission source categories in the Dallas-Fort Worth 1997 eight-hour ozone nonattainment area: industrial cleaning solvents; flexible package printing; paper, film, and foil coatings; large appliance coatings; metal furniture coatings;

miscellaneous metal and plastic parts coatings; miscellaneous industrial adhesives; and automobile and light-duty truck coatings. The adopted rules affect the following seven emission source categories in the Houston-Galveston-Brazoria 1997 eight-hour ozone nonattainment area: industrial cleaning solvents; flexible package printing; paper, film, and foil coatings; large appliance coatings; metal furniture coatings; miscellaneous metal and plastic parts coatings; and miscellaneous industrial adhesives. The proposed rules were published in the June 24, 2011, issue of the *Texas Register* (36 TexReg 3834). (Amy Browning, Frances Dowiak) (Rule Project No. 2010-016-115-EN)

Adopt the repeal of 30 TAC Section 115.437, amendments to certain Sections of 30 TAC Chapter 115, creation of certain new Sections to 30 TAC Chapter 115 and the corresponding revisions to the state implementation plan, as recommended by the Executive Director. BG/CR; all agree.

#### Item 182 **Docket No. 2010-1773-RUL.**

Consideration of the adoption of amendments to Sections 115.110, 115.112 - 115.114, and 115.119; repeal of Sections 115.115 – 115.117; and new Sections 115.111 and 115.115 – 115.118 of 30 TAC Chapter 115, Control of Air Pollution from Volatile Organic Compounds, and corresponding revisions to the state implementation plan. The adoption will require a more stringent level of control for volatile organic compounds (VOC) storage in the Dallas-Fort Worth 1997 eight-hour ozone nonattainment area and reduce VOC emissions, including benzene, from oil and gas production sources. The proposed rules were published in the June 24, 2011, issue of the *Texas Register* (36 TexReg 3801) (Amy Browning, Robert Gifford) (Rule Project No. 2010-025-115-EN).
