PROPOSAL FOR DECISION

Item 1 **[TCEQ Docket No. 2005-1490-WR; SOAH Docket No. 582-10-4184.](#)**

Consideration of the Administrative Law Judge's Proposal for Decision regarding the application of Brazos River Authority (BRA) for a new permit pursuant to rules of the Texas Commission on Environmental Quality and Tex. Water Code Chapter 11 to authorize a new appropriation of state water in the amount of 421,449 acre-feet per year, which includes existing and future return flows in the basin for multiple uses including domestic, municipal, agricultural, industrial, mining, and other beneficial uses on a firm basis in the Brazos River Basin. BRA requests use of up to 90,000 acre-feet of water per year of its firm supply (part of the 421,449 acre-feet of firm water requested above) to produce, along with other unappropriated flows, an interruptible water supply of 670,000 acre-feet per year and the appropriation of that interruptible water supply (which also includes existing and future return flows); an exempt interbasin transfer authorization to transfer and use, on a firm and interruptible basis, such water in the adjoining San Jacinto-Brazos Coastal Basin and the Brazos-Colorado Coastal Basin, and to transfer such water to any county or municipality or the municipality's retail service area that is partially within the Brazos River Basin for use, on a firm and interruptible basis, in that part of the county or municipality and the municipality's retail service area not within the Brazos River Basin. BRA's service area includes the following counties: Parmer, Castro, Swisher, Bailey, Lamb, Hale, Floyd, Cochran, Hockley, Archer, Lubbock,

Crosby, Baylor, Dickens, King, Knox, Jack, Terry, Lynn, Mitchell, Chambers, Young, Garza, Throckmorton, Kent, Haskell, Stonewall, Parker, Palo Pinto, Dawson, Scurry, Borden, Fisher, Stephens, Jones, Shackelford, Johnson, Hood, Nolan, Erath, Eastland, Taylor, Callahan, Somervell, Hill, Comanche, Bosque, Brown, Freestone, Hamilton, McLennan, Limestone, Mills, Coryell, Leon, Falls, Lampasas, Robertson, Bell, Madison, Milam, Burnet, Brazos, Grimes, Williamson, Burleson, Travis, Lee, Washington, Bastrop, Fayette, Waller, Harris, Austin, Colorado, Fort Bend, Galveston, Matagorda, Wharton, and Brazoria. The Commission will also consider the record, timely related filings, exceptions and replies. (Robin Smith, Ron Ellis)

Remand this matter to the State Office of Administrative Hearings (SOAH) pursuant to 30 Texas Admin. Code Section 80.265 and Texas Gov't Code Section 2003.047(m) with instructions to abate the hearing to allow the Applicant to provide additional information to the Executive Director related to their permit application in the form of a Water Management Plan. 2) Require BRA to submit its Water Management Plan to the Executive Director within 10 months from the date of this Order. If BRA does not meet this requirement within this timeframe, then the Commission directs the ALJs to draft a proposed Order denying BRA's permit application that is consistent with the ALJs' analysis and conclusions that BRA did not meet the requirements for issuance of the requested permit. The ALJs should focus the proposed Order on the issues that led to their recommended denial. 3) Provide 7 months for the Executive Director's review of the Water Management Plan including necessary supplemental information and compliance with applicable additional public participation requirements. BRA shall promptly respond to any requests for additional information by the Executive Director within 20 days of any such requests. 4) Upon completion of the Executive Director's review and compliance with additional applicable public participation requirements, direct the ALJs to reopen the record and hold a hearing on the new information, including the proposed permit application, as modified by the Water Management Plan pursuant to applicable legal requirements including Tex. Water Code Sections 11.134 and 5) Direct the ALJs draft a revised Proposal for Decision and proposed Order within 24 months from the date of this Order and allow parties an opportunity to file Exceptions and Replies in accordance with TCEQ rules. CR/BG; all agree.

Grant the hearing requests filed by Kevin McNary and Henry Perez; refer the hearing requests to SOAH with a concurrent referral to ADR on the following issues: A) Whether the facility can comply with the nuisance odor control requirements at 30 TAC Section 309.13(e); B) Whether

the Applicant has met the buffer zone requirements in 30 TAC Section 309.13(c); C) Whether the facility will have a negative impact on the health of the requestors and their families; D) Whether the proposed flows will have a negative impact on the aquatic life and contact recreational uses in the Guadalupe River; E) Whether the proposed flows will have a negative impact on public water supply and nearby private water wells; F) Whether the application is complete; and G) Whether the facility will adversely impact endangered species; Specify a hearing duration of 9 months; Direct the Executive Director to participate as a party in the contested case hearing; and deny all requests for reconsideration. BG/CR; all agree.

Item 3 [TCEQ Docket No. 2011-1490-MWD.](#)

Consideration of the application by City of Denison for renewal of Texas Pollutant Discharge Elimination System (TPDES) Permit No. WQ0010079003 which authorizes the discharge of treated domestic wastewater with a daily average flow not to exceed 6,000,000 gallons per day. The wastewater treatment facility is located east of the City of Denison approximately 1600 feet east and 2,200 feet north of the intersection of Center Street and Farm-to-Market Road 120 in Grayson County, Texas. The Commission will also consider requests for hearing or reconsideration, related responses and replies, public comment, and the Executive Director's Response to Comments. (Alicia Ramirez, Donald J. Camp, P.E.)

Deny the request for reconsideration and the hearing request filed by Mrs. James Clement pursuant to Tex. Water Code Section 26.028(d); issue the Executive Director's draft permit renewal to the City of Denison; and adopt the Executive Director's Response to Comments. CR/BG; all agree.

The amendments to TWC require the TCEQ to make changes to the compliance history rule. This proposed rulemaking would revise Chapter 60. The purpose of this proposed rulemaking is to allow the Commission to use new standards instead of the existing uniform standard for evaluating and using compliance history. In addition, the proposed rulemaking modifies the components and formula of compliance history in order to provide a more accurate measure of regulated entities' performance and make compliance history a more effective regulatory tool. Approve publication of, and hearing on, amendments to 30 TAC Chapter 60 regarding Compliance History, as recommended by the Executive Director with the following change: Direct staff to include language in the preamble specifically soliciting public comment on amended 30 TAC Section 60.2(e)(2) with regard to how the Agency can account for various sized regulated entities within the program areas or media other than those program areas or media currently contemplated by the proposed rule language. BS/CR; all agree.

Consideration for publication of proposed new Sections 90.1, 90.2, 90.3, 90.10 - 90.16, 90.20 - 90.24, 90.30, and 90.31 and repealed Sections 90.1, 90.2, 90.10, 90.12, 90.14, 90.16, 90.18, 90.20, 90.30, 90.32, 90.34, 90.36, 90.38, 90.40, 90.42, 90.44, 90.50, 90.52, 90.54, 90.56, 90.58, 90.60, 90.62, 90.64, 90.66, 90.68, 90.70, and 90.72 of 30 TAC Chapter 90, Innovative Programs. The proposed rulemaking would implement HB 2694, Articles 4.01, 4.06, and 4.08, 82nd Legislature, 2011, Regular Session, which amends the TWC, §§5.751, 5.755, and 5.758. The amendments to TWC changed the standard for TCEQ to manage its environmental incentives and innovative programs. Therefore, TCEQ proposes to consolidate and reorganize its rules regarding these

The proposed rulemaking would also provide clarity and remove unnecessary restrictions on the TCEQ's ability to issue Regulatory Flexibility Orders and to recognize Environmental Management Systems.
