The proposed rulemaking would establish notice and consent requirements for spent lead-acid batteries intended for reclamation in a foreign country, establish an alternative set of generator requirements applicable to laboratories owned by eligible academic entities and address the specific nature of hazardous waste generation and accumulation in these laboratories, make a number of technical corrections to the hazardous waste regulations in numerous final rules previously published in the Federal Register, such as typographical errors, incorrect or outdated citations, and omissions, remove "saccharin and its salts" from the lists of hazardous constituents and commercial chemical products which are hazardous wastes when discarded or intended to be discarded, incorporate technical corrections from 40 Code of Federal Regulations Part 262, Subpart K, include corrections to existing Used Oil Rules in 30 TAC Chapter 324, include corrections to existing Manifest Rules in 30 TAC Chapter 335, include corrections to previously adopted language from Checklists: 208, 213, 214, 215 and require a new permit owner to provide acceptable financial assurance on the date of a permit transfer.
