MISCELLANEOUS MATTERS

Item 1 **[Docket No. 2013-0174-WR.](#)**

Consideration of a petition filed under Texas Water Code § 11.451 by the Brazos River Coalition and signed by 37 water right holders on the Brazos River seeking the appointment of a Watermaster for the entire Brazos River Basin. The Commission will also consider the Executive Director's Executive Summary of the petition. The Brazos River and its tributaries cover all or portions of Archer, Austin, Bailey, Baylor, Bell, Borden, Bosque, Brazoria, Brazos, Brown, Burleson, Burnet, Callahan, Castro, Cochran, Comanche, Coryell, Crosby, Dawson, Dickens, Eastland, Erath, Falls, Fisher, Floyd, Fort Bend, Freestone, Garza, Grimes, Hale, Hamilton, Haskell, Hill, Hockley, Hood, Jack, Johnson, Jones, Kent, King, Knox, Lamb, Lampasas, Lee, Leon, Limestone, Lubbock, Lynn, Madison, McLennan, Milam, Mills, Nolan, Palo Pinto, Parker, Parmer, Robertson, Scurry, Shackelford, Somervell, Stephens, Stonewall, Swisher, Taylor, Terry, Throckmorton, Waller, Washington, Williamson, and Young Counties.

Find that the Petition filed by the Brazos River Coalition was signed by 25 or more water rights holders on the Brazos River; Refer the Petition to the State Office of Administrative Hearings for a hearing on: A) Whether the rights of senior water right holders in the River Basin or segment of the River Basin are threatened; B) Whether a need exists for an

appointment of a Watermaster; and C) The appropriate geographical boundaries for any recommended Watermaster program; Specify that the maximum duration of the hearing is eight months from the preliminary hearing to the issuance of the Proposal for Decision. TB/CR; all agree.

Item 2 **Docket No. 2013-0225-WR.**

Consideration of whether to affirm, modify, or set aside an Emergency Order issued by the Executive Director (ED) on January 29, 2013, under Tex. Water Code § 11.139, to the Lower Colorado River Authority (LCRA) to amend its 2010 Water Management Plan (WMP), Permit No. 5838. The Emergency Order grants LCRA's request to temporarily change the process required in its 2010 WMP for curtailment of interruptible stored water. LCRA has the right to divert and use up to 1.5 million acre feet from Lakes Buchanan and Travis, in Travis, Llano, and Burnet Counties, Texas, under Certificates of Adjudication Nos. 14-5478 and 14-5482. These certificates require LCRA to develop the WMP, Permit No. 5838, which provides how LCRA makes water available from these lakes to help meet "firm" water customer needs, downstream interruptible irrigation demands, and environmental flow needs of Matagorda Bay and the Lower Colorado River. The WMP also provides how LCRA will manage and curtail supplies from the lakes during times of drought including through a repeat of the Drought of Record. Due to the extreme drought, LCRA requested an emergency order to change the triggers for curtailment of interruptible water based on storage levels of Lakes Buchanan and Travis on March 1, 2013. The ED's Emergency Order temporarily amends the WMP by revising the trigger dates, combined storage levels, and release amounts for providing service to LCRA's interruptible customers for first and second crop irrigation, as was requested by LCRA. (Robin Smith, Kelley Rila)

Affirm the Emergency Order issued by the Executive Director on January 29, 2013 which granted the Lower Colorado River Authority's request to amend its 2010 Water Management Plan, Permit No. 5838 with the following modifications: 1) Revise Finding of Fact No. 33 to read: "If the lake levels drop more quickly than arrangements for alternative intakes or supplies can be implemented, the current drought presents an imminent threat to the LCRA water systems and its customers' water systems"; 2) Revise the second sentence of Finding of Fact No. 35 to read: "Thus, the emergency authorization is the only means by which LCRA could be provided with the flexibility necessary under the present conditions to determine if it can commit the supply of uninterruptible stored water to its irrigation operations"; 3) Revise Ordering Provision No. 3 to read: "This Order shall continue until one of the following occurs: A) The issuance of any TCEQ Order approving the LCRA's March 12, 2012 Application for amendments to the 2010 Water Management Plan; or B) The expiration of the initial 120 day period allowed by Texas Water Code § 11.139 and any extension that may be granted pursuant to Texas Water Code § 11.139"; and 4) Delete Ordering Provision No. 4 and renumber the remaining Ordering Provisions.
