making the other resulting "flow-through" changes to any other category that will be affected by these changes; and 5) using the ED's proposed fixed and variable cost percentages for the rate design with the tiered gallonage ranges proposed in the application; Direct the ALJs and the parties to calculate the 51% Rule using the formula and figures for revenues generated by the previous rates and proposed rates in Attachment D to the ED's Exceptions; but recalculate the revenues generated by the new rates based on the Commission's minor changes to the ALJs' revenue requirement; Direct the ALJs to modify the proposed Order to incorporate the ALJs' recommendations in their letter response to exceptions; Direct the ALJs to report back to the Commission how the Commission's decisions would change the blank amounts and resulting figures in the ALJs' proposed Order; and Upon return, the Commission intends to direct OGC in its final motion after remand to modify the ALJs' Order: 1) to memorialize the Commission's determination that the Applicant has satisfied the statutory requirements for approving a consolidated tariff based on the record evidence: 2) to more clearly implement the approval for the other tariff charges; 3) to clarify the customer refund/credit provision: i) to establish a 0.21% refund interest rate based the PUC's 2013 rate; ii) to direct that the Applicant must calculate and account for all sums of minimum and gallonage rates overcharged for each customer; and iii) to specify that the overcharges may be subject to a refund or credit to all current customers or all connections; and 4) to remove the findings concerning the two regulatory approvals.
