EMERGENCY ORDER

Item 2 **[Docket No. 2013-0225-WR.](#)**

Consideration of whether to affirm, modify, or set aside an Order issued by the Executive Director (ED) on May 17, 2013 extending an Emergency Order issued under Tex. Water Code § 11.139 to the Lower Colorado River Authority (LCRA), which allows LCRA to temporarily amend its 2010 Water Management Plan (WMP), Permit No. 5838 by changing the triggers for curtailment of

interruptible water based on storage levels of Lakes Buchanan and Travis. The ED's Extension of the Emergency Order grants LCRA's request to extend the Commission's Emergency Order of February 19, 2013 through October 15, 2013. LCRA has the right to divert and use up to 1.5 million acre feet from Lakes Buchanan and Travis in Travis, Llano, and Burnet Counties, Texas, under Certificates of Adjudication Nos. 14-5478 and 14-5482. These certificates require LCRA to develop the WMP, Permit No. 5838, which establishes how LCRA is to make water available from these lakes to help meet "firm" water customer needs, downstream interruptible irrigation demands, and environmental flow needs of Matagorda Bay and the Lower Colorado River; and how LCRA will manage and curtail supplies from the lakes during times of drought including through a repeat of the Drought of Record. Affirm the Emergency Order renewal issued by the Executive Director on May 17, 2013 and made effective May 29, 2013, which extends the authority granted to the Lower Colorado River Authority to amend its 2010 Water Management Plan Permit No. 5838 with the following modifications: Revise Ordering Provision No. 1 to read: "The emergency order amending LCRA's Water Management Plan, Permit No. 5838, as modified by the Commission, is extended through July 29, 2013".
