The City provides water service to La Villa ISD. La Villa ISD's allegedly affected facilities encompass an early college high school, alternative high school, middle school and elementary school located in the City. La Villa ISD alleges that, on or about December 10, 2013, the City issued a letter that included a 10 day disconnection notice effective on December 20, 2013, by 5:00 pm, unless the payment of an alleged outstanding balance of \$57,212.69 was submitted. La Villa ISD alleges that the City terminated water and sewer service to La Villa ISD's facilities on or before December 25, 2013. La Villa ISD's request seeks an emergency order, with or without a hearing, that immediately compels the City to provide and restore water and sewer service to La Villa ISD and restrains the City from directly or indirectly terminating water and sewer service to the various schools of La Villa ISD for a period of at least 90 days and until further order of the Commission. La Villa filed a previous emergency order request with the Commission on December 17, 2013; which the Commission considered at an emergency agenda on December 20, 2013. The Commission determined to take no action on La Villa ISD's request at the emergency agenda.

Decline to take action on La Villa ISD's petition for an emergency order for the following reasons: 1) the Commission lacks jurisdiction over the underlying billing dispute between the City's municipally-owned utility and any retail customer within the corporate limits of the City; 2) the Commission has questionable authority to issue an emergency order to compel the City to provide continuous and adequate water service without the City holding a water CCN; and 3) the request does not demonstrate an imminent threat to public health and safety. BS/TB; ZC abstained.
