TPDES Permit No. WQ0003511000 for industrial wastewater is hereby issued to Dos Republicas Coal Partnership, as set out in the Draft Permit with the following modification;" L) Delete Ordering Provision Nos. 1a, 1b, and 1c; M) Amend Ordering Provision 1d by deleting the sentence that states "Results of the analytical testing must be submitted within 90 days of the final sampling event for each outfall to the TCEQ Industrial Permit Team (MC-148);" and replace the sentence with "Results of the analytical testing must be submitted within 90 days of each of the four discharges for each outfall to the TCEQ Industrial Permit Team (MC-148). Sample and analyze the first discharge that occurs after a 24-month period following the fourth discharge, and the first discharge after each successive 24-month period following the previous sampled discharge, for each outfall utilizing the same procedures set forth in this provision;" and N) Add new Ordering Provision No. 4 that states: "The Executive Director's Response to Comments is hereby adopted pursuant to 30 TAC §§ 50.117 and 80.126."; Approve issuance of the ED's Draft Permit as modified by the ALJs in their June 9, 2016 letter, but also modified by the Commission from the dais here today; and Adopt the ED's Response to Comments. Grant the hearing requests of Beneficial Land Management, L.L.C., Victoria County, and Dorothy Simons; Deny all remaining hearing requests; Refer the matter to the Commission's Alternative Dispute Resolution Program to run concurrently with the SOAH scheduling process; Refer the matter to SOAH for a contested case hearing on the following issues: A) Whether the draft permit is sufficiently protective of surface water quality; B) Whether the draft permit is sufficiently protective of groundwater; C) Whether the draft permit is sufficiently protective of the health of the requesters'; D) Whether the draft permit is sufficiently protective of flora and fauna; E) Whether the draft permit provides for adequate buffer zones; F) Whether the draft permit is likely to result in nuisance odors; G) Whether the application provides sufficient justification to authorize under the provisions of 30 Texas Administrative Code Chapter 312, the beneficial land application of grit trap and grease trap waste processed with sewage sludge; H) Whether the application provides sufficient justification to include an experimental use authorization for the land application of grit trap and grease trap waste processed with sewage sludge in the draft permit; Deny the request for reconsideration; and Specify that the maximum duration of the hearing is nine months from the preliminary hearing to issuance of the Proposal for Decision.
