The Petition for Inquiry alleges that: i) the groundwater in the management area is not adequately protected by the rules adopted by the district; and ii) the groundwater in the management area is not adequately protected due to the failure of the district to enforce substantial compliance with its rules. (Bastrop, Brazos, Burleson, Falls, Fayette, Freestone, Lee, Leon, Limestone, Madison, Milam, Navarro, Robertson, and Williamson Counties). (Robin Smith)

The rules were amended to implement portions of Senate Bill (SB) 1731, 85th Texas Legislature, 2017, Regular Session. These changes include a change to the name of the DTIP to the Seaport and Rail Yard Areas Emissions Reduction Program. Additional changes are proposed by the executive director to clarify requirements and establish more specific criteria for implementing the program rules. The proposed revisions to the DERIP and DTIP guidelines were made available for public comment. Comments received have been considered and responded to in the Response to Comments.
