Consideration for publication of proposed amended Sections 17.14 and 17.17 of 30 TAC Chapter 17, Tax Relief for Property Used for Environmental Protection; and Sections 18.25, 18.26, and 18.30 of 30 TAC Chapter 18, Rollback Relief for Pollution Control Requirements. The proposed rulemaking would revise the Tier I Tables in Section

17.14(a) and Section 18.25(a) consistent with the Tax Relief for Pollution Control Property Advisory Committee's formal recommendations. The proposed revisions would add heat recovery steam generators with a partial use determination of 65% and 11 other pollution control property items to both Tier I Tables. Other revisions are proposed to accommodate the addition of the Tier I Table property items at a partial use percentage. The proposed rulemaking would also implement Senate Bill 2, Section 44 from the 86th Texas Legislature, 2019, Regular Session, which requires rulemaking to revise the title of Chapter 18 from Rollback Relief for Pollution Control Requirements to Voter-Approval Tax Rate Relief for Pollution Control Requirements. Finally, the proposed rulemaking would fulfill the commission's statutory and regulatory requirements to review and update the property included on the Chapters 17 and 18 Expedited Review Lists (ERL) and Tier I Tables. Both ERLs are proposed for revision only to establish consistency with both Tier I Tables. (Elizabeth Sartain, Don Redmond) (Rule Project No. 2020-031-018-AI)

Approve the publication of the amended Sections of 30 Texas Administrative Code Chapters 17 and 18, as recommended by the Executive Director. EL/BJ; all agree.

Item 42 **Docket No. 2018-0983-RUL.**

Consideration for publication of proposed amended Sections 30.20, 30.24, 30.33, 30.34, 30.36, 30.81, 30.95, 30.129, and 30.402; and new Section 30.29 of 30 TAC Chapter 30, Occupational Licenses and Registrations. The proposed rulemaking would implement House Bill (HB) 1508, 85th Texas Legislature, 2017, Regular Session, relating to notice to applicants regarding the consequences of a criminal conviction on eligibility for an occupational license; and HB 1342, Senate Bill (SB) 37, and SB 1217, 86th Texas Legislature, 2019, Regular Session, relating to notice to individuals regarding the licensing authority's intention to deny an individual a license based on criminal history, the prohibition on denying or suspending an occupational license due to an individual's default on student loans, and the prohibition on including an arrest that did not result in a conviction in a licensing authority's determination of a person's fitness to perform the duties and responsibilities of a licensed occupation. The proposed rulemaking would also include administrative changes to ensure current and accurate cross-references. (Rebecca Moore, Hollis Henley) (Rule Project No. 2018-024-030-WS)

Approve the publication of the proposed amendments and new Section to 30 Texas Administrative Code Chapter 30, as recommended by the Executive Director. BJ/EL; all agree.

Consideration of the adoption of amended Sections 116.110, 116.116, 116.710, and 116.721 and new Section 116.118 of 30 TAC Chapter 116, Control of Air Pollution by Permits for New Construction or Modification, and corresponding revisions to the State Implementation Plan. The adoption revises Chapter 116 to implement provisions of House Bill 2726, 86th Texas Legislature, 2019, Regular Session, which revised Texas Health and Safety Code, Section 382.004.
