Docket No. 2020-0973-MWD.

Consideration of the application by Regal, LLC, for a new Texas Pollutant Discharge Elimination System Permit No. WQ0015817001, which authorizes the discharge of treated domestic wastewater at a daily average flow not to exceed 80,000 gallons per day. The facility will be located approximately 1.2 miles east of the intersection of Farm-to-Market Road 1978 and State Highway 123, in Guadalupe County, Texas 78666. The Commission will also consider requests for hearing or reconsideration, related responses and replies, public comment, and the Executive Director's response to comments. Grant the hearing requests of the City of San Marcos; Refer the application to SOAH for a contested case hearing on the following issues: 1) Whether the draft permit is protective of livestock and wildlife, including endangered species and aquatic vegetation in the City's ETJ and immediate vicinity of the proposed facility and discharge route; 2) Whether the draft permit is protective of water quality and the existing uses in the receiving waters under the applicable surface water quality standards of 30 TAC Chapter 307; 3) Whether the draft permit is protective of groundwater in the area; 4) Whether the draft permit complies with applicable requirements to abate and control nuisance orders, as set forth in 30 TAC § 309.13; 5) Whether the Commission should deny or alter the terms and conditions of the draft permit based on consideration of need under Texas Water Code § 26.0282, and the general policy to promote regional or area-wide systems under Texas Water Code § 26.081; 6) Whether the draft permit is protective of the health of the City's citizens in the immediate vicinity of the proposed facility and discharge route; and 7) Whether the Applicant's Compliance History for the previous five years raises issues regarding the Applicant's ability to comply to the material terms of the permit that warrant altering the terms of the permit; Refer the matter to the Commission's Alternative Dispute Program to run concurrently with SOAH's scheduling processes; Set a hearing duration of 180 days from the date of the preliminary hearing until the Proposal for Decision is issued; and Deny the requests for reconsideration.
