

## **NOTICE OF HEARING XAVIER FRANK SOAH Docket No. 582-18-5013 TCEQ Docket No. 2018-0947-LIC**

### **APPLICATION.**

Xavier Frank, 14242 Royal Hill Drive, Houston, Texas 77083, has applied to the Texas Commission on Environmental Quality (TCEQ) for renewal of a Customer Service Inspector License. The Executive Director denied Mr. Frank's application for cause. Mr. Frank has requested a formal hearing on the Executive Director's decision. During the review of Mr. Frank's application, the Executive Director discovered that Mr. Frank was convicted of a Second Degree Felony in 2017. The Executive Director denied Mr. Frank's application because this citation was for an offense that directly relates to the duties and responsibilities of the licensed occupation.

### **CONTESTED CASE HEARING.**

The State Office of Administrative Hearings (SOAH) will conduct a formal contested case hearing on this application at:

The purpose of a preliminary hearing is to establish jurisdiction, name the parties, establish a procedural schedule for the remainder of the proceeding, provide an opportunity for settlement discussions, and address other matters as determined by the administrative law judge. The preliminary hearing will be held unless all timely hearing requests are withdrawn or the parties agree to waive the preliminary hearing.

The evidentiary phase of the contested case hearing, to be held at a later date, will be a legal proceeding similar to a civil trial in state district court to determine whether Mr. Frank should be issued a Customer Service Inspector License. Unless agreed to by all parties in attendance at the preliminary hearing, an evidentiary hearing will not be held on the date of this preliminary hearing. **If Xavier Frank fails to appear at the preliminary hearing or evidentiary hearing, the Executive Director will request that the hearing be canceled and that the appeal of the Executive Director's decision be dismissed.**

**SOAH's rules allow for participation by telephone or videoconference. Permission must be obtained from SOAH at least ten days before the hearing.**

Legal Authority: Texas Water Code Chapters 5 and 37; Texas Occupations Code Chapter 53; Texas Government Code, Chapter 2001; 30 Texas Administrative Code (TAC) Chapter 30, and the procedural rules of the TCEQ and SOAH, including 30 TAC Chapters 70 and 80 and 1 TAC Chapter 155.
