## NOTICE OF HEARING BASF CORPORATION SOAH Docket No. 582-18-5014 TCEQ Docket No. 2018-0852-WR

### PETITION.

BASF Corporation (BASF) has filed a complaint with the Texas Commission on Environmental Quality (TCEQ) under Sections 11.038 and 11.041 of the Texas Water Code alleging that Dow Chemical Company (DOW) has refused to sell water to BASF at a just reasonable price, that Dow has water available, and BASF is entitled to receive and use the available water.

#### **CONTESTED CASE HEARING.**

The State Office of Administrative Hearings (SOAH) will conduct a preliminary hearing on this petition at:

10:00 a.m. – September 24, 2018 William P. Clements Building 300 West 15th Street, 4th Floor Austin. Texas 78701

The purpose of a preliminary hearing is to establish jurisdiction, name the parties, establish a procedural schedule for the remainder of the proceeding, allow an opportunity for settlement discussions, and to address other matters as determined by the judge. The evidentiary hearing phase of the hearing will be similar to a civil trial in state district court. The hearing will be conducted in accordance with Chapter 2001, Texas Government Code, Texas Water Code Chapter 11; TCEQ rules, including 30 Texas Administrative Code (TAC) Chapter 291; and the procedural rules of the TCEQ and SOAH, including 30 TAC Chapter 80 and 1 TAC Chapter 155. To participate in the evidentiary hearing as a party, you must attend the preliminary hearing and show that you would be affected by the petition in a way not common to members of the general public.

In accordance with 1 Tex. Admin. Code § 155.401(a), Notice of Hearing, "Parties that are not represented by an attorney may obtain information regarding contested case hearings on the public website of the State Office of Administrative Hearings at <a href="www.soah.texas.gov">www.soah.texas.gov</a>, or in printed format upon request to SOAH."
