About TNGVGP Grants

We provide incentive grants for entities that currently operate heavy-duty or medium-duty motor vehicles in Texas to repower the vehicles with a natural gas or propane engine or replace the vehicle with a natural gas or propane vehicle.

Who's Eligible

- Individuals
- Corporations
- Organizations
- Governments or governmental subdivisions or agencies
- Business trusts
- Partnerships
- Associations
- Other legal entities

Vehicles/Engines Eligible for Replacement/Repower must be:

- Powered by diesel or gasoline
- A heavy-duty or medium duty vehicle greater than 8,500 lbs.

Natural Gas Vehicles/Engines Eligible for Purchase:

- A TCEQ-approved natural gas vehicle/engine powered by CNG, LNG, or LPG*
- Of the same type and general weight class as the old vehicle/engine

Grant Amounts

Some applicants may qualify for up to 90% of the cost to repower or replace their vehicle. Visit the TERP website to see how much you may qualify for!
