Changes to Public Water Supply Rule Published in Texas Register

On Feb. 6, 2015, a proposed rule was published by the TCEQ in the Texas Register that will address the following issues for public water supplies:

- federal changes to the lead and E.coli thresholds
- desalination of groundwater
- chloramination
- plan review submittal process
- enforceability of exceptions
- other drinking water matters

Several processes that previously required an exception request will now be allowed without an exception. The requirements for these technologies will be part of the rule.

They include:

- use of chloramines,
- use of desalination technology for groundwater, and
- alternative appurtenances for overflow devices.

Look for Rule Project No. 2013-046-290-OW. The rule appears on Commissioner’s Agenda for Adoption, July 1, 2015. ■

The State of Texas will stop issuing inspection stickers and transition to a “Two Steps, One Sticker” vehicle inspection and registration program. Beginning March 1, 2015, vehicles will no longer be issued an inspection sticker. Your registration sticker will serve as a combined proof of registration and inspection.

Computer-Based Testing Now Available for Occupational Licensing

Many of the exams for individuals seeking an occupational license are available through computer-based testing (CBT), including initial exams and retests. CBT offers:

- Immediate exam score with e-mail option
- Immediate printed exam analysis feedback with e-mail option
- License issued within one week of exam date
- Immediate retesting available with certain conditions
- Daily access and expanded hours for CBT exam sites

Wastewater reuse and land application facilities are required to report to the TCEQ on monthly effluent report forms. If you do not have a prepared MER form and you need to submit a report, blank MER templates are now available at TexasEnviroHelp.org and at www.tceq.texas.gov/assistance/water/wastewater/reporting-on-monthly-effluent-report-mer-forms. ■

TCEQ Trade Fair to be Held May 5-6 in Austin

The TCEQ will hold its 2015 Environmental Trade Fair and Conference on May 5-6 at the Austin Convention Center.

The Trade Fair is the TCEQ's largest event, hosting about 4,000 people. More than 100 educational sessions on topics from oil and gas to wastewater permitting will be offered, as well as more than 300 exhibits showcasing the latest environmental information and products. The TCEQ's Environmental Assistance Division will offer a track at this year's conference

as an “Introduction to Environmental Regulations.” This track will include the following sessions:

- Air Permitting Overview
- Stormwater Permitting
- Waste Reduction Policy Act

The Trade Fair is a great opportunity to earn continuing education credits, learn about the latest regulations, and network with TCEQ staff and others in the environmental field.

Guidelines Amended for Effluent Limitations for Construction Stormwater Discharges

On Feb. 4, 2015, the TCEQ commissioners approved the adoption of federal revisions to regulations on stormwater discharges from construction activities. The adopted federal regulations became effective on Feb. 26, 2015, and will be incorporated into the Construction General Permit (TXR150000) at its renewal in 2018. The revisions include:

- Clarifying the applicability of best management practices (BMPs) to control erosion caused by stormwater discharges, such as erosion and sediment controls, and the requirements for soil stabilization and pollution prevention measures;
- Providing additional details on areas where buffers are required;
- Withdrawing the numeric limit for turbidity and associated monitoring requirements; and
- Adding a definition for “infeasible.”


