



**Figure 1: Number of NOV's**




**Figure 2: Number of Effective Orders**




**Figure 3: Assessed Penalties**

For fiscal year 2016 through **April**, TCEQ has:

- Issued **12,813** Notices of Violation
- Issued **893** Administrative Orders (see <http://www2.tceq.texas.gov/epic/eenf/>);
- Assessed **\$9,589,855** in administrative penalties; and
- Approved **101** Supplemental Environmental Projects.

Judgments have been received on **14** cases referred by TCEQ to the Attorney General and the AG has **262** TCEQ cases pending. AG actions typically take from 6 months to 5 years from referral to judgment.
