Figure 1: Number of NOVs




Figure 2: Number of Effective Orders




Figure 3: Assessed Penalties




Figure 4: Supplemental Environmental Projects




Figure 5: Number of Backlogged Orders




Figure 6: Summary

For fiscal year 2012 through **June**, TCEQ has:

- Issued **12,406** Notices of Violation
- Issued **1,411** Administrative Orders (see <http://www5.tceq.state.tx.us/eenf/>);
- Assessed **\$12,721,080** in administrative penalties; and
- Approved **120** Supplemental Environmental Projects.

Judgments have been received on **31** cases referred by TCEQ to the Attorney General and the AG has **274** TCEQ cases pending. AG actions typically take from 6 months to 5 years from referral to judgment.
