Overview

This form is used to register an authorized account representative for an account (portfolio) used to comply with the Emissions Banking and Trading (EBT) rules in 30 Texas Administrative Code (TAC) Chapter 101, Subchapter H. The authorized account representative must meet, or be authorized by someone that meets, the responsible official qualifications in 30 TAC §122.165(c).

A primary or alternate authorized account representative must certify (sign) all EBT forms submitted for that account (portfolio). The TCEQ will send all official correspondence relating to EBT actions to the authorized account representative(s) via e-mail unless specifically requested to send paper copies via regular mail. Correspondence will be address to the primary authorized account representative and courtesy copies will be sent to the alternate representative, if designated.

Beginning November 1, 2015, each account (portfolio) used to comply with the EBT rules must have a primary authorized account representative. Each portfolio may also elect to have one alternate authorized account representative. This form should be included with the initial submittal of a required EBT application form and re-submitted as necessary to register new authorized account representative(s) or to update the contact information for the current representative(s).
