

# Rule History Title 30 Texas Administrative Code Chapter 115 Transport Vessels

---

## Introduction

The official version of the rules in [Chapter 115, Subchapter C, Division 3](#) is available on the Secretary of State's website.

Each revision is identified by the date the commission adopted the changes. When available, the rule project number, which is the unique identification number from the rules tracking database for the specific rule project, is also provided for reference.

The *Texas Register* publications of the rule proposal and adoption are given for each revision. The proposed rules are approved by the commissioners to be published in the *Texas Register* for public comment. Once adopted by the commissioners, the rules are republished as final in the *Texas Register*.

These rules are submitted for United States Environmental Protection Agency (EPA) approval as part of the State Implementation Plan (SIP) control strategy to meet the National Ambient Air Quality Standard (NAAQS) for ozone. Links to the *Federal Register* publication of the EPA's approval of these rules and the associated SIP revisions are also included.

The summary information includes the affected sections of the rule, the counties affected, the compliance date, and a brief description of the rule revisions. If the adopted rule does not provide for additional time to comply with any new or revised requirements then compliance with any rule revisions is required by the effective date of the rulemaking.

Summary:

The rulemaking requires owners and operators of transport vessels in Wise County to comply with the same rule requirements that currently apply to transport vessels located in the other nine DFW counties.

The rulemaking is necessary to satisfy federal reasonably available control technology (RACT) requirements for Wise County as a result of the DFW nonattainment area designation under the 2008 eight-hour ozone NAAQS. Summary:

The rulemaking establishes the testing, recordkeeping, and inspection requirements for gasoline tank-truck tanks located in the covered ozone attainment counties.

The rulemaking also updates references; adds exemptions; adds recordkeeping requirements for gasoline tank-truck tank leak testing in the covered attainment counties; and clarifies rule requirements.

Summary:

The rulemaking extends the annual leak-tightness test requirement to include all tank-trucks transporting VOCs meeting a minimum true vapor pressure.

The rulemaking establishes exemptions for tank-truck tanks used exclusively to transport VOCs meeting a minimum true vapor pressure and for transport vessels other than tank-truck tanks.

The rulemaking extends rule requirements to Brazoria, Chambers, Collin, Denton, El Paso, Fort Bend, Galveston, Harris, Liberty, Montgomery, and Waller Counties to ensure that all nonattainment areas are subject to the same level of control.

The rulemaking also changes the Subchapter title from 'VOC Marketing Operations' to 'VOC Transfer Operations.'

Summary:

The rulemaking establishes requirements for VOC leaks from gasoline tank-truck tanks in the new Chapter 115. The rulemaking is part of the reorganization and reformatting of the Chapter 115 rules.

The rulemaking specifies applicable inspection procedures and schedules; identifies federally approved test methods and procedures; and specifies the type of records to be kept to document compliance.

Summary:

The rulemaking establishes the new VOC control, testing, and recordkeeping requirements for gasoline tank-trucks in Harris County.

The rulemaking requires a leak-tight test of any gasoline tank-truck prior to being filled or emptied; limits the change in pressure; and requires records of all certification testing and repairs to be maintained.

The rulemaking implements requirements based on the EPA's 1978 *Control of Volatile Organic Compound Leaks from Gasoline Tank Trucks and Vapor Collection Systems* ([EPA-450/2-78-051](#)).

The rulemaking is necessary to satisfy federal RACT requirements.
