

Rule History Title 30 Texas Administrative Code Chapter 115 Water Separation

Introduction

The official version of the rules in [Chapter 115, Subchapter B, Division 3](#) is available on the Secretary of State's website.

Each revision is identified by the date the commission adopted the changes. When available, the rule project number, which is the unique identification number from the rules tracking database for the specific rule project, is also provided for reference.

The *Texas Register* publications of the rule proposal and adoption are given for each revision. The proposed rules are approved by the commissioners to be published in the *Texas Register* for public comment. Once adopted by the commissioners, the rules are republished as final in the *Texas Register*.

These rules are submitted for United States Environmental Protection Agency (EPA) approval as part of the State Implementation Plan (SIP) control strategy to meet the National Ambient Air Quality Standard (NAAQS) for ozone. Links to the *Federal Register* publication of the EPA's approval of these rules and the associated SIP revisions are also included.

The summary information includes the affected sections of the rule, the counties affected, the compliance date, and a brief description of the rule revisions. If the adopted rule does not provide for additional time to comply with any new or revised requirements then compliance with any rule revisions is required by the effective date of the rulemaking.

Summary:

The rulemaking requires that the owner or operator of each volatile organic compound (VOC) water separator located in Wise County to comply with the same rules that currently apply to sources located in the other nine DFW counties. The rulemaking also establishes a compliance deadline for sources in the DFW area becoming subject to the rules on or after the compliance deadline.

The rulemaking is necessary to satisfy federal reasonable available control technology (RACT) requirements for Wise County as a result of the DFW nonattainment area designation under the 2008 eight-hour ozone NAAQS.

Summary:

This rulemaking updates monitoring and recordkeeping requirements for Victoria County to facilitate reclassification to attainment.

Summary:

The rulemaking extends controls to properties located in the new counties that have been designated as nonattainment (Chambers, Collin, Denton, Fort Bend, Hardin, Liberty, Montgomery, and Waller Counties).

The rulemaking expands the applicability of VOC water separators in Dallas and Tarrant Counties by eliminating an exemption and lowering an exemption threshold.

The rulemaking lowers the exemption threshold for VOC water separators; requires control equipment maintenance records to be kept and that these, and all records, be maintained for at least two years; and moves the existing requirements for sources in Gregg, Nueces, and Victoria Counties to a separate subsection in each section, but does not impose any new requirements on sources in these three counties.

The rulemaking is necessary to ensure all nonattainment counties are subject to the same level of control to satisfy federal reasonably available control technology requirements.

Summary:

The rulemaking requires all sources other than petroleum refineries to implement controls on any VOC water separator that separates materials having a true vapor pressure of at least 0.5 pounds per square inch absolute, regardless of daily throughput.

The rulemaking requires similar controls for separators located at petroleum refineries; eliminates the exemption for VOC water separators used exclusively in conjunction with crude oil and condensate production after August 31, 1990; and specifies necessary recordkeeping requirements for all affected facilities.

Summary:
