



SIP Revision: Houston-Galveston-Brazoria (HGB) 1997 Eight-Hour Ozone Nonattainment Area, May 23, 2007

On May 23, 2007, the Texas Commission on Environmental Quality (TCEQ) adopted a State Implementation Plan (SIP) revision for the HGB 1997 eight-hour ozone nonattainment area.

Summary of the SIP Revision

EPA Action: Reasonably available control technology (RACT) analysis approved on March 27, 2015 ([80 FR 16291](#), [79 FR 21144](#), [78 FR 19599](#))

Background: Effective June 15, 2004, the HGB area (Brazoria, Chambers, Fort Bend, Galveston, Harris, Liberty, Montgomery, and Waller Counties) was designated nonattainment for the 1997 eight-hour ozone National Ambient Air Quality Standard (NAAQS) ([69 FR 23951](#)). The area was classified as moderate nonattainment with an attainment date of June 15, 2010.

On May 23, 2007, the commission adopted the 2007 HGB 1997 Eight-Hour Ozone Nonattainment Area SIP Revision along with associated rules and the [2007 HGB 1997 Eight-Hour Ozone Nonattainment Area Reasonable Further Progress SIP Revision](#). On June 15, 2007, the TCEQ submitted the SIP revisions to the EPA along with a request that the HGB area be reclassified from a moderate to a severe nonattainment area for the 1997 eight-hour ozone NAAQS, with an attainment deadline of June 15, 2019. Key Changes: The 2007 HGB 1997 Eight-Hour Ozone Nonattainment Area SIP Revision was the first step in addressing the 1997 eight-hour ozone standard in the HGB area. This SIP revision included:

- A RACT analysis;
- Additional Voluntary Mobile Emissions Reduction Program (VMEP) commitments; and
- The Texas 2002 Periodic Emissions Inventory for the HGB 1997 eight-hour ozone nonattainment area.

This SIP revision also incorporated amendments to 30 Texas Administrative Code (TAC) Chapter 114 to add certain marine fuels to the Texas Low Emission Diesel (TxLED) rules and Chapter 115 to address under-estimated, unreported, or under-reported volatile organic compounds (VOC) emissions from storage tank floating roof landings, flash emissions, and from degassing storage tanks, transport vessels, and marine vessels with liquid heels. In another associated rulemaking project (Rule Project no. 2006-034-117-EN), 30 TAC Chapter 117 was reformatted and the 10 nanogram per Joule heat input (ng/J) NO_x standard for residential water heaters was repealed in accordance with House Bill 965, 79th Legislature, 2005. The emission standard of 40 ng/J NO_x was retained.
