1. Certification of Ownership, Usage, and Condition

By signing this form, the owner certifies that the following requirements are met for all activities. Refer to the attached list counties inside the Clean Transportation Zone (CTZ) to determine county eligibility.

- a. Operation.** The vehicle has been continuously owned, leased, or otherwise commercially financed and operated in Texas as a fleet vehicle for at least the two years immediately preceding the submission of this form. The owner has been listed on the front of the title document for the preceding two years.
- b. Registration.** The vehicle has been continuously located and used inside the CTZ for the preceding two years. In addition, the vehicle has been continuously registered for operation in a county located within the CTZ for the preceding two years.
- c. Condition.** The vehicle is currently in good operating condition and capable of performing its primary function in the routine operations of the owner at the time of signature. To the best of the owner's knowledge, the vehicle has a remaining useful life of 2 or more years, taking into account normal maintenance, repairs, and upkeep.
- d. Inspection.** The vehicle has a current safety inspection or complies with other equivalent safety requirements.
- e. Documentation.** A copy of the vehicle title or lease agreement, and a copy of the current and previous registration has been provided to the applicant. Vehicles with apportioned registrations will require data-based travel logs or usage summaries to be submitted with this form.
