- AE completed Task 4 and submitted a Deliverable Report. Task 4 included preparing the Kingsbery substation and completing the civil work to install the Energy Storage System (ESS). To complete the task, AE poured all concrete pads for ESS equipment, implemented the grounding grid, and installed all trenching and conduit for the communications and auxiliary power required for the successful operations of the system.
- PowerFin Partners (PowerFin) continued construction activities including PV module and inverter installation as well as interconnection equipment such as the switchgear and primary metering cabinet installation and cable pulling for the Community Solar facility under Task 5.
- AE and TCEQ signed an amendment to change the deadline for Task 5 completion.
- AE continued installation and assembly work for the ESS inside the Kingsbery substation as part of the work to be completed under Task 6, and is on task to be completed prior to February 28, 2018.
