- [§117.131\(1\)](#) Exemption for utility electric power boilers or stationary gas turbines.
- [§117.133\(2\)\(A\)](#) Exemption for stationary gas turbines and auxiliary boilers used solely to power other units during start-ups.
- [§117.133\(2\)\(B\)](#) Exemption for stationary gas turbines and auxiliary boilers that operate no more than an average of 10% of the hours of the year.
