

**Announcement of Draft Federal Operating Permit
For Minor Permit Revision**

Draft Permit No.: O4232

Application and Draft Permit. Delaware Processing LLC, 1722 Routh St Ste 1300, Dallas, TX 75201-2502, has applied to the Texas Commission on Environmental Quality (TCEQ) for a minor revision of its existing Federal Operating Permit (herein referred to as Permit) No. O4232, Application No. 36561, to authorize operation of the Tiger Compressor Station, a NATURAL GAS EXTRACTION facility. The area addressed by this application is located at: From Angeles take US HWY 285 N for 8.2 mi turn L on lease rd for 1.6 mi to facility in Angeles, Culberson County, Texas 79770. This application was received by TCEQ on April 18, 2024.

The purpose of a federal operating permit is to improve overall compliance with the rules governing air pollution control by clearly listing all applicable requirements, as defined in Title 30 Texas Administrative Code § 122.10. The draft permit, if approved, will codify the revised conditions under which the area must operate. The permit will not authorize new construction. The TCEQ Executive Director has completed the technical review of this application and prepared a draft permit. The TCEQ Executive Director recommends issuance of this permit.
