## Announcement of Draft Federal Operating Permit For Minor Permit Revision

Draft Permit No.: O2407

**Application and Draft Permit.** Georgia-Pacific Wood Products LLC, PO Box 105605, Atlanta, GA 30348-5605, has applied to the Texas Commission on Environmental Quality (TCEQ) for a minor revision of its existing Federal Operating Permit (herein referred to as Permit) No. O2407, Application No. 37746, to authorize operation of the Pineland Manufacturing Complex, an All Other Miscellaneous Wood Product Manufacturing facility. The area addressed by this application is located at approximately 1 mile east of Highway 96 on FM1, then approximately 1.4 miles east on FM2426 on North side, 1 Denning St. in Pineland, Sabine County, Texas 75968. This application was received by TCEQ on March 6, 2025.

The purpose of a federal operating permit is to improve overall compliance with the rules governing air pollution control by clearly listing all applicable requirements, as defined in Title 30 Texas Administrative Code § 122.10. The draft permit, if approved, will codify the revised conditions under which the area must operate. The permit will not authorize new construction. The TCEQ Executive Director has completed the technical review of this application and prepared a draft permit. The TCEQ Executive Director recommends issuance of this permit.
