

Announcement of Draft Federal Operating Permit For Minor Permit Revision

Draft Permit No.: O411

Application and Draft Permit. Midcoast G & P (East Texas) L.P., 600 Travis St Ste 5500, Houston, TX 77002-3008, has applied to the Texas Commission on Environmental Quality (TCEQ) for a minor revision of its existing Federal Operating Permit (herein referred to as Permit) No. O411, Application No. 38830, to authorize operation of the Plum Creek Treating Facility, a NATURAL GAS EXTRACTION facility. The area addressed by this application is located at 2.7 miles south of Lanely on Hwy 489, off west side of Hwy or from Dew, go east on Hwy 489 approximately 6.0 miles to Hwy 1848 south, drive approximately 3.0 miles the plant will be on the right. in Lanely, Freestone County, Texas 75831. This application was received by TCEQ on August 20, 2025.

The purpose of a federal operating permit is to improve overall compliance with the rules governing air pollution control by clearly listing all applicable requirements, as defined in Title 30 Texas Administrative Code § 122.10. The draft permit, if approved, will codify the revised conditions under which the area must operate. The permit will not authorize new construction. The TCEQ Executive Director has completed the technical review of this application and prepared a draft permit. The TCEQ Executive Director recommends issuance of this permit. A notice of proposed final action that includes a response to comments and identification of any changes to the draft permit will be mailed to everyone who submitted public comments for this application.
