To Whom It May Concern,

General Motors LLC (GM) hereby applies for a minor revision of existing Title V Federal Operating Permit (FOP) O1151 for the Arlington Assembly Plant located in Arlington, TX.

As indicated in a separate letter being submitted, per 40 CFR Part 60, Subpart MMa 60.395a (a)(3) to TCEQ and USEPA Region VI, the vehicle paint shop at the plant is planning to make certain physical changes to prime coating operation to increase hourly vehicle painting capacity from 60.5 jobs per hour (JPH) to 62.5 JPH. Existing prime booth coating operation is subject to 40 CFR 60 Subpart MM. The physical changes to the operation meets the definition of "modification" per 40 CFR 60.14(a), and therefore modified prime coating operation will be subject to the requirements of 40 CFR 60, Subpart MMa.

GM understands that the facility will be able to start the modified primer operation after Title V minor revision application is submitted in STEERS ePermits. GM intends to start operating the modified prime coating operation on or after 02/10/2025.

This application is being submitted through STEERS ePermits. Based on the guidance provided by Mr. Christopher Crider of TCEQ to Mr. Apurva Pujara of GM, the following forms are submitted with this minor revision application:

1. Form OP-2
2. Form OP-REQ3
3. Form OP-SUMR

The following forms are not submitted with the application based on the guidance provided by Mr. Christopher Crider.

- OP-UA – This form is not required since the new NSPS MMa is not yet included in UA forms and since the flow charts are not yet developed by TCEQ for this new regulation.
