Hi Mr. Swami.

I am responding to your request for a review of the draft Title V permit on behalf of Tejas Power Generation.

We are in agreement with the requirements that were added to the permit; however, we noticed some errors within the document that need to be corrected. In 3 different places, a Special Term and Condition was added where it did not need to be added as it was a repeat of the previous condition. I am going to list these out with pasted excerpts from the permit so that you can see what I am referring to:

- 1. Special Term and Condition 18 and 19:
 - 18. For unit GT-1, GT-2, GT-3 and GT-4 (identified in the Certificate of Representation as unit CT-1, CT-2, CT-3 and CT-4), located at the affected source identified by ORIS/Facility code 60468, the designated representative and the owner or operator, as applicable, shall comply with the following Acid Rain Permit requirements.
 - 19. For units (insert unit ID numbers for units subject to Acid Rain) (identified in the Certificate of Representation as units (insert EPA unit ID numbers)), located at the affected source identified by ORIS/Facility/Plant code (insert the ORIS/Facility/Plant ID), the designated representative and the owner or operator, as applicable, shall comply with the following Acid Rain Permit requirements.
- 2. Special Term and Condition 20 and 21:
 - For units GT-1, GT-2, GT-3 and GT-4 (identified in the Certificate of Representation as units CT-1, CT-2, CT-3 and CT-4), located at the site identified by Plant code/ORIS/Facility code 60468, the designated representative and the owner or operator, as applicable, shall comply with the following CSAPR requirements.
 - 21.  - (i) The CSAPR subject unit(s), and the unit-specific monitoring provisions at this source, are identified in the following paragraph(s). These unit(s) are subject to the requirements for the CSAPR NO_x Ozone Season Group 2 Trading Program.
 - (1) For units GT-1, GT-2, GT-3 and GT-4, the owners and operators shall comply with the continuous emission monitoring system or systems (CEMS) requirements pursuant to 40 CFR Part 75, Subpart H for NOx, and with the excepted monitoring system requirements for gas- and oilfired units pursuant to 40 CFR Part 75, Appendix D for heat input.
 - (2) For unit(s) [insert unit ID numbers for units that are complying with this provision], the owners and operators shall comply with the continuous emission monitoring system or systems (CEMS) requirements pursuant to 40 CFR Part 75, Subpart H for NOx, and with the excepted monitoring system requirements for gas- and oil-fired units pursuant to 40 CFR Part 75, Appendix D for heat input.

Section 1 Introduction

Tejas Power Generation, LLC (Tejas) is authorized to operate Tejas Power Generation Unit 1 by Electric Generation Unit (EGU) Standard Permit (SP) Number 103230 and EGU SP Number 170722. The EGUSP 103230 authorizes one natural gas-fired simple cycle Siemens 501D combustion turbine and related equipment. The EGUSP 170722 authorizes three (3) natural gas-fired simple cycle General Electric (GE) LM6000 combustion turbines and related equipment. All equipment is authorized under the Federal Operating Permit (FOP) number O-3999, which was recently issued by the Texas Commission On Environmental Quality (TCEQ) on February 23, 2024.

On May 9, 2024 the Environmental Protection Agency (EPA) finalized the Standards of Performance for Greenhouse Gas Emissions for Modified Coal-Fired Steam Electric Generating Units and New Construction and Reconstruction Stationary Combustion Turbine Electric Generating Units, 40 Code of Federal Regulations (CFR) 60, Subpart TTTTa. This regulation applies to any stationary combustion turbine that commences construction or reconstruction after May 23, 2023, that has a base load rating greater than 260 gigajoules per hour (GJ/h) (250 million British thermal units per hour (MMBtu/h)) of fossil fuel and serves a generator or generators capable of selling greater than 25 megawatts (MW) of electricity to a utility power distribution system. The three new LM6000 turbines that are currently under construction at the Tejas Power Generation Unit 1 site meet the applicability to this subpart; therefore, a minor permit revision is being submitted.

The following equipment is currently authorized for construction at the Tejas facility under Standard Permit 30 TAC §116.610 and §116.615:

- One simple-cycle Siemens 501D gas combustion turbine
- Three (3) GE LM 6000 simple-cycle natural gas combustion turbines

- Turbine lube oil recirculation systems
