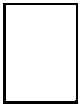

Good afternoon all,

My Team Leader has not finished reviewing this project, but as I mentioned for the Plains Texas Facility (38003), the same updates will be needed for this project. I will be on vacation from 09/18 – 10/03 so I just wanted to get ahead of this before I left. Please address the following by **Friday, 10/03**.

- **Compliance Plan (OP-ACPS)** - The compliance plan should contain enforceable language. Activities/ milestones should be written as directives or should state that the applicant “will” or “shall” do the listed action. The milestones should be dated so that there is a deadline for each item. These deadlines should be in the Month, Day, Year format. The first two milestones regarding scheduling and conducting the tests should include a deadline like this, so for example “Schedule initial performance testing by December 31, 2025.”, “Conduct initial performance testing by March 31, 2026.”, etc. These deadlines are not saying that the activity will occur on those exact dates, but that the applicant will complete the item on or before that time. Then, the exception to a specific date is if a milestone will directly relate to the completion of a previous milestone. The final milestone is “Submit a report for initial performance testing.” Since NSPS JJJJ requires that a performance test report be submitted within 60 days after completing the test, the applicant could revise that to “Submit a report for initial performance testing within 60 days of conducting the testing.” Please provide me with an updated compliance plan. In addition, each compliance plan should include a milestone for completion of the plan: ““Company A shall submit a confirmation letter to TCEQ once the corrective action plan is completed.”
- Please update the Permit shield reason on the OP-REQ2 for GRP-EGU for NSPS IIII from “The proposed engines...” to just “The engines” since the compliance plans for conducting performance tests suggest that at least some of these engines are operational.

Good afternoon all,

I have conducted a technical review of the significant revision application for RPC Power LLC, Plains Texas II Facility. An electronic copy of the Working Draft Permit (WDP) is attached for your review. This WDP contains the TCEQ determination of applicable requirements based on the information submitted in your application, and any updates provided. Please review the WDP and submit to me any comments you have on the working draft permit by **Monday, July 14th**. Please also see my notes below.

1. **Permit Shield for MACT ZZZZ - § 63.6590(c)(1) – GRP-EGU** – The permit shield for engines subject to 63.6590(c) was incorrectly granted in the initial issuance of this permit and should not have been included. This is not an overlap provision like other Part 63 NESHAP standards. The regulation is very clear that the affected sources are meeting the requirements of 40 CFR Part 63, Subpart ZZZZ by complying with 40 CFR Part 60, Subpart IIII or JJJJ depending on whether the engine is a CI or SI engine. Therefore, I have removed the permit shield from the WDP. Please also remove this entry from the OP-REQ2 and provide me with an updated copy. Let me know if you have any questions about this and I would be happy to clarify.
2. **Form OP REQ1 – Page 89 - NSR Authorization No. 172515** has been amended since the issuance of your initial permit. The most recent issuance date is now 09/26/2024 according to our records. Please provide me with an updated copy of page 89 of the OP-REQ1 so we can incorporate this change.

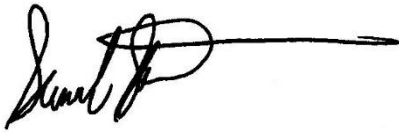
