The updated OP-REQ1, pg.89 was received in STEERS. I added PBR 106.533 to the NSR Authorization References table and fixed the formatting on term and condition 5 as shown in the effective permit. Attached is the updated WDP and below are the screenshots of the updates. Please review and respond to the updates by **3 pm tomorrow October 3, 2025**.

5. For the unit PRO-1 and PRO-2, which has a sulfur feed rate limited to less than 2 LTPD H₂S, the permit holder shall comply with the following alternative compliance conditions related to 40 CFR Part 60, Subpart LLL:

$$X = 3.707 \times 10^{-7}(Q_a)(Y)$$

where:

X = Estimated sulfur feed rate in long tons per day.

Q_a = Volumetric flow rate of acid gas from gas sweetening unit in dry standard cubic feet per day.

The readings from the process flowmeter shall be used to determine the volumetric flow rate of the acid gas from the sweetening unit.

Volumetric flow rate shall be measured daily and the highest volumetric flow rate in the calendar month shall be used to estimate sulfur feed rate.

Y = H₂S concentration in acid gas feed from sweetening unit in percent by volume. The H₂S concentration shall be monitored and recorded every calendar month by one of the following options.

- A The Tutwiler procedure in 40 CFR § 60.648 or a chromatographic procedure following

I have conducted a technical review of the minor revision application for Targa Pipeline Mid-Continent WestTex LLC , Midkiff Gas Plant. An electronic copy of the Working Draft Permit (WDP) is attached for your review. This WDP contains the TCEQ determination of applicable requirements based on the information submitted in your application, and any updates provided.

The following revisions were completed:

- Emergency generator EGEN6 was removed.
- Emergency generator ENG-3 was added.

I have been assigned to the Federal Operating Permit (FOP) minor revision application of Permit No. O3120 for Targa Gas Processing LLC, Midkiff Gas Plant. This application has been assigned Project No. 38237.

Please address all correspondence pertaining to this permit application, including any updates, to me at the address below, and use both the Permit and Project reference numbers above to facilitate tracking.

In addition, I wanted to let you know that EPA has, on occasion, objected to Title V permits based on the following:
