The executive director has determined the application is administratively complete and will conduct a technical review of the application. Information in the application indicates that this permit renewal would not result in an increase in allowable emissions and would not result in the emission of an air contaminant not previously emitted. The TCEQ may act on this application without seeking further public comment or providing an opportunity for a contested case hearing if certain criteria are met.

PUBLIC COMMENT. You may submit public comments to the Office of the Chief Clerk at the address below. The TCEQ will consider all public comments in developing a final decision on the application and the executive director will prepare a response to those comments. Issues such as property values, noise, traffic safety, and zoning are outside of the TCEQ's jurisdiction to address in the permit process.

OPPORTUNITY FOR A CONTESTED CASE HEARING. You may request a contested case hearing if you are a person who may be affected by emissions of air contaminants from the facility. If requesting a contested case hearing, you must submit the following: (1) your name (or for a group or association, an official representative), mailing address, daytime phone number; (2) applicant's name and permit number; (3) the statement "[l/we] request a contested case hearing;" (4) a specific description of how you would be adversely affected by the application and air emissions from the facility in a way not common to the general public; (5) the location and distance of your property relative to the facility; (6) a description of how you use the property which may be impacted by the facility; and (7) a list of all disputed issues of fact that you submit during the comment period. If the request is made by a group or association, one or more members who have standing to request a hearing must be identified by name and physical address. The interests the group or association seeks to protect must also be identified. You may also submit your proposed adjustments to the application/permit which would satisfy your concerns.

The deadline to submit a request for a contested case hearing is 15 days after newspaper notice is published. If a request is timely filed, the deadline for requesting a contested case hearing will be extended to 30 days after mailing of the response to comments.

If any requests for a contested case hearing are timely filed, the Executive Director will forward the application and any requests for a contested case hearing to the Commissioners for their consideration at a scheduled Commission meeting. Issues such as property values, noise, traffic safety, and zoning are outside of the Commission's jurisdiction to address in this proceeding.



Instructions for Public Notice For New Source Review Air Permit Renewal

Notice of Receipt of Application and Intent to Obtain Permit

Your application has been declared administratively complete and now you must comply with the following instructions:

Review Notice

Included in the notice is all of the information which the commission believes is necessary to effectuate compliance with applicable public notice requirements. Please read it carefully and notify the Texas Commission on Environmental Quality (TCEQ) immediately if it contains any errors or omissions. You are responsible for ensuring the accuracy of all information published. You may not change the text of the notice without prior approval from the TCEQ.

Newspaper Notice

- You must publish the enclosed *Notice of Receipt of Application and Intent to Obtain Permit* within **30 calendar days** after the date of administrative completeness. Refer to the cover letter for the date of administrative completeness.
- You must publish the enclosed *Notice of Receipt of Application and Intent to Obtain Permit* at your expense, in a newspaper that is of general circulation in the municipality where the facility is or will be located. If the facility is not located within a municipality, the newspaper should be of general circulation in the municipality nearest to the location or proposed location.
- You must publish this notice in one issue of any applicable newspaper.
- You will find two example notices enclosed in this package. Example A must be published in the "public notice" section of the newspaper. The phrase "Example A" is not required to be published. Example B must be published in the same issue of the newspaper as Example A; however, it must be published in a prominent location (other than the public notice section). Example B refers the public to the "public notice" section of the newspaper where Example A provides more information regarding the permit application.
- Example B must be a total of at least 6 column inches (standard advertising units) with a height of at least 3 inches and a horizontal dimension of 2 column widths. If the newspaper chosen does not use standard advertising units for measurement, the notice must be at least 12 square inches with the shortest side at least 3 inches.
- The bold text of the enclosed notice must be printed in the newspaper in a font style or size
 that distinguishes it from the rest of the notice (i.e., bold, italics). Failure to do so may require
 re-notice.

Alternative Language Notice

- In certain circumstances, applicants for air permits must complete notice in alternative languages.
- Public notice rules require the applicant to determine whether a bilingual program is required at
 either the elementary or middle school nearest to the facility or proposed facility location.
 Bilingual education programs are determined on a district-wide basis. When students who are
 required to attend either school are eligible to be enrolled in a bilingual education program,
 some alternative language notice is required (signs, or signs and newspaper notice).
- Since the school district, and not the schools, must provide the bilingual education program, these programs do not have to be located at the elementary or middle school nearest to the facility or proposed facility to trigger the alternative language notice requirement. If there are students who would normally attend the nearest schools eligible to be taught in a bilingual education program at a different location, alternative language notice is required.
- If triggered, publication of alternative language notices must be made in a newspaper or publication primarily printed in each language taught in the bilingual education program. This notice is required if such a newspaper or publication exists in the municipality or the county where the facility is or will be located.
- The applicant must demonstrate a good faith effort to identify a newspaper or publication in the
 required language. If a newspaper or publication of general circulation published at least once a
 month in such language cannot be found, publishing in that language is not required, but signs
 must still be posted adjacent to each English language sign.
- Publication in an alternative language section or insertion within an English language newspaper does not satisfy these requirements.
- The applicant has the burden to demonstrate compliance with these requirements. You must fill
 out the *Public Notice Verification Form (Form TCEQ-20244)* indicating your compliance with
 the requirements regarding publication in an alternative language. This form is available at
 www.tceq.texas.gov/permitting/air/nav/air_publicnotice.html.
- It is suggested the applicant work with the local school district to do the following:
 - (a) determine if a bilingual program is required in the district;
 - (b) determine which language is required by the bilingual program;
 - (c) locate the nearest elementary and middle schools; and
 - (d) determine if any students attending either school are eligible to be enrolled in a bilingual educational program.
- If you determine that you must meet the alternative language notice requirements after receipt of the full public notice package, you are responsible for ensuring that the publication in the alternative language is complete and accurate in that language. Spanish notice templates are available through the Air Permits Division Web site at www.tceq.texas.gov/permitting/air/nav/air_publicnotice.html. All italic notes should be replaced with the corresponding Spanish translations for the specific application and published in the alternative language publication. Email a copy to Air Permits Division staff.
- If you are required to publish notice in a language other than Spanish, you must translate the entire public notice at your own expense.

Public Comment Period

- The public comment period should last at least 30 calendar days. With the exception of renewals whose comment period should last at least 15 calendar days.
- The comment period will be longer if the last day of the public comment period ends on a
 weekend or a holiday. In this case, the comment period will end on the next business day.
- The comment period for the permit may lengthen depending on whether a public meeting is held or if second notice is required. If a public meeting is held, the comment period will be extended to the later of either the date of the public meeting or the end of the second notice period.

Proof of Publication

- Check each publication to ensure that the articles were accurately published. If a notice was not published correctly you may be required to republish.
- For each newspaper in which you published, you must submit proof of publication that shows the notice, the date of publication, and the name of the newspaper to the Office of the Chief Clerk within **10 business days** after the date of publication. Acceptable proofs of publication are 1) copies of the published notice or 2) the newspaper clippings of the published notice. If you choose to submit copies of the published notice to the Office of the Chief Clerk, copies must be on standard-size 8½" x 11" paper and must show the actual size of the published notice (do not reduce the image when making copies). Published notices longer than 11" must be copied onto multiple 8½" x 11" pages. Please note, submitting a copy of your published notice could result in faster processing of your application. It is recommended that you maintain newspaper clippings or tear sheets of the notice for your records.
- You must submit an affidavit of publication for air permitting and alternate language
 affidavit of publication for air permitting (if applicable) to the Office of the Chief Clerk within
 30 calendar days after the date of publication. You must use the enclosed affidavits of
 publication. The affidavits must clearly identify the applicant's name and permit number. You
 are encouraged to submit the affidavit with proof of publication described above.

Failure to Publish and Submit Proof of Publication

You must meet all publication requirements. **If you fail to publish the notice or submit proof of publication** *on time***, then** the TCEQ may suspend further processing on your application or take other actions.

Sign Posting

Applicants for air quality permits must also post signs.

- You must post at least one sign in English and as applicable, in each alternative language.
- Signs must be in place on the first day of publication in a newspaper and must remain in place and be legible and be visible from the street for the entire duration of the publications' designated comment period (see Example C).
- The sign template enclosed (*Example C*) is an example only. Read the sign template carefully and notify the TCEQ if it has an error or omissions. It is your responsibility to verify that the appropriate information pertaining to your application is accurate. Any changes to the text prepared by the TCEQ must be approved by the agency.
- Signs placed at the site must be located within 10 feet of each (every) property line paralleling a public street, road, or highway. Signs must be spaced at not more than 1,500-foot intervals. If requesting a contested case hearing, you must submit the following: (1) your name (or for a group or association, an official representative), mailing address, daytime phone number; (2) applicant's name and permit number; (3) the statement "[l/we] request a contested case hearing;" (4) a specific description of how you would be adversely affected by the application and air emissions from the facility in a way not common to the general public; (5) the location and distance of your property relative to the facility; (6) a description of how you use the property which may be impacted by the facility; and (7) a list of all disputed issues of fact that you submit during the comment period. If the request is made by a group or association, one or more members who have standing to request a hearing must be identified by name and physical address. The interests the group or association seeks to protect must also be identified. You may also submit your proposed adjustments to the application/permit which would satisfy your concerns.

The deadline to submit a request for a contested case hearing is 15 days after newspaper notice is published. If a request is timely filed, the deadline for requesting a contested case hearing will be extended to 30 days after mailing of the response to comments.

If any requests for a contested case hearing are timely filed, the Executive Director will forward the application and any requests for a contested case hearing to the Commissioners for their consideration at a scheduled Commission meeting. Unless the application is directly referred to a contested case hearing, the executive director will mail the response to comments along with notification of Commission meeting to everyone who submitted comments or is on the mailing list for this application. The Commission may only grant a request for a contested case hearing on issues the requestor submitted in their timely comments that were not subsequently withdrawn. If a hearing is granted, the subject of a hearing will be limited to disputed issues of fact or mixed questions of fact and law relating to relevant and material air quality concerns submitted during the comment period. Issues such as property values, noise, traffic safety, and zoning are outside of the Commission's jurisdiction to address in this proceeding.

MAILING LIST. In addition to submitting public comments, you may ask to be placed on a mailing list for this application by sending a request to the Office of the Chief Clerk at the address below. Those on the mailing list will receive copies of future public notices (if any) mailed by the Office of the Chief Clerk for this application.



Instructions for Public Notice For New Source Review Air Permit Renewal

Notice of Receipt of Application and Intent to Obtain Permit

Your application has been declared administratively complete and now you must comply with the following instructions:

Review Notice

Included in the notice is all of the information which the commission believes is necessary to effectuate compliance with applicable public notice requirements. Please read it carefully and notify the Texas Commission on Environmental Quality (TCEQ) immediately if it contains any errors or omissions. You are responsible for ensuring the accuracy of all information published. You may not change the text of the notice without prior approval from the TCEQ.

Newspaper Notice

- You must publish the enclosed *Notice of Receipt of Application and Intent to Obtain Permit* within **30 calendar days** after the date of administrative completeness. Refer to the cover letter for the date of administrative completeness.
- You must publish the enclosed *Notice of Receipt of Application and Intent to Obtain Permit* at your expense, in a newspaper that is of general circulation in the municipality where the facility is or will be located. If the facility is not located within a municipality, the newspaper should be of general circulation in the municipality nearest to the location or proposed location.
- You must publish this notice in one issue of any applicable newspaper.
- You will find two example notices enclosed in this package. Example A must be published in the "public notice" section of the newspaper. The phrase "Example A" is not required to be published. Example B must be published in the same issue of the newspaper as Example A; however, it must be published in a prominent location (other than the public notice section). Example B refers the public to the "public notice" section of the newspaper where Example A provides more information regarding the permit application.
- Example B must be a total of at least 6 column inches (standard advertising units) with a height of at least 3 inches and a horizontal dimension of 2 column widths. If the newspaper chosen does not use standard advertising units for measurement, the notice must be at least 12 square inches with the shortest side at least 3 inches.
- The bold text of the enclosed notice must be printed in the newspaper in a font style or size
 that distinguishes it from the rest of the notice (i.e., bold, italics). Failure to do so may require
 re-notice.

Alternative Language Notice

- In certain circumstances, applicants for air permits must complete notice in alternative languages.
- Public notice rules require the applicant to determine whether a bilingual program is required at
 either the elementary or middle school nearest to the facility or proposed facility location.
 Bilingual education programs are determined on a district-wide basis. When students who are
 required to attend either school are eligible to be enrolled in a bilingual education program,
 some alternative language notice is required (signs, or signs and newspaper notice).
- Since the school district, and not the schools, must provide the bilingual education program, these programs do not have to be located at the elementary or middle school nearest to the facility or proposed facility to trigger the alternative language notice requirement. If there are students who would normally attend the nearest schools eligible to be taught in a bilingual education program at a different location, alternative language notice is required.
- If triggered, publication of alternative language notices must be made in a newspaper or publication primarily printed in each language taught in the bilingual education program. This notice is required if such a newspaper or publication exists in the municipality or the county where the facility is or will be located.
- The applicant must demonstrate a good faith effort to identify a newspaper or publication in the
 required language. If a newspaper or publication of general circulation published at least once a
 month in such language cannot be found, publishing in that language is not required, but signs
 must still be posted adjacent to each English language sign.
- Publication in an alternative language section or insertion within an English language newspaper does not satisfy these requirements.
- The applicant has the burden to demonstrate compliance with these requirements. You must fill
 out the *Public Notice Verification Form (Form TCEQ-20244)* indicating your compliance with
 the requirements regarding publication in an alternative language. This form is available at
 www.tceq.texas.gov/permitting/air/nav/air_publicnotice.html.
- It is suggested the applicant work with the local school district to do the following:
 - (a) determine if a bilingual program is required in the district;
 - (b) determine which language is required by the bilingual program;
 - (c) locate the nearest elementary and middle schools; and
 - (d) determine if any students attending either school are eligible to be enrolled in a bilingual educational program.
- If you determine that you must meet the alternative language notice requirements after receipt of the full public notice package, you are responsible for ensuring that the publication in the alternative language is complete and accurate in that language. Spanish notice templates are available through the Air Permits Division Web site at www.tceq.texas.gov/permitting/air/nav/air_publicnotice.html. All italic notes should be replaced with the corresponding Spanish translations for the specific application and published in the alternative language publication. Email a copy to Air Permits Division staff.
- If you are required to publish notice in a language other than Spanish, you must translate the entire public notice at your own expense.

Public Comment Period

- The public comment period should last at least 30 calendar days. With the exception of renewals whose comment period should last at least 15 calendar days.
- The comment period will be longer if the last day of the public comment period ends on a
 weekend or a holiday. In this case, the comment period will end on the next business day.
- The comment period for the permit may lengthen depending on whether a public meeting is held or if second notice is required. If a public meeting is held, the comment period will be extended to the later of either the date of the public meeting or the end of the second notice period.

Proof of Publication

- Check each publication to ensure that the articles were accurately published. If a notice was not published correctly you may be required to republish.
- For each newspaper in which you published, you must submit proof of publication that shows the notice, the date of publication, and the name of the newspaper to the Office of the Chief Clerk within **10 business days** after the date of publication. Acceptable proofs of publication are 1) copies of the published notice or 2) the newspaper clippings of the published notice. If you choose to submit copies of the published notice to the Office of the Chief Clerk, copies must be on standard-size 8½" x 11" paper and must show the actual size of the published notice (do not reduce the image when making copies). Published notices longer than 11" must be copied onto multiple 8½" x 11" pages. Please note, submitting a copy of your published notice could result in faster processing of your application. It is recommended that you maintain newspaper clippings or tear sheets of the notice for your records.
- You must submit an affidavit of publication for air permitting and alternate language
 affidavit of publication for air permitting (if applicable) to the Office of the Chief Clerk within
 30 calendar days after the date of publication. You must use the enclosed affidavits of
 publication. The affidavits must clearly identify the applicant's name and permit number. You
 are encouraged to submit the affidavit with proof of publication described above.
- You must submit the *Public Notice Verification Form (Form TCEQ-20244)* to the Office of the Chief Clerk within 10 business days of the end of this public comment period. You must use this form to certify that you have met alternative language notice requirements. This form is available at

Failure to Publish and Submit Proof of Publication

You must meet all publication requirements. **If you fail to publish the notice or submit proof of publication** *on time***, then** the TCEQ may suspend further processing on your application or take other actions.

Sign Posting

Applicants for air quality permits must also post signs.

- You must post at least one sign in English and as applicable, in each alternative language.
- Signs must be in place on the first day of publication in a newspaper and must remain in place and be legible and be visible from the street for the entire duration of the publications' designated comment period (see Example C).

If requesting a contested case hearing, you must submit the following: (1) your name (or for a group or association, an official representative), mailing address, daytime phone number; (2) applicant's name and permit number; (3) the statement "[l/we] request a contested case hearing;" (4) a specific description of how you would be adversely affected by the application and air emissions from the facility in a way not common to the general public; (5) the location and distance of your property relative to the facility; (6) a description of how you use the property which may be impacted by the facility; and (7) a list of all disputed issues of fact that you submit during the comment period. If the request is made by a group or association, one or more members who have standing to request a hearing must be identified by name and physical address. The interests the group or association seeks to protect must also be identified. You may also submit your proposed adjustments to the application/permit which would satisfy your concerns.

The deadline to submit a request for a contested case hearing is 15 days after newspaper notice is published. If a request is timely filed, the deadline for requesting a contested case hearing will be extended to 30 days after mailing of the response to comments.

If any requests for a contested case hearing are timely filed, the Executive Director will forward the application and any requests for a contested case hearing to the Commissioners for their consideration at a scheduled Commission meeting. Unless the application is directly referred to a contested case hearing, the executive director will mail the response to comments along with notification of Commission meeting to everyone who submitted comments or is on the mailing list for this application. The Commission may only grant a request for a contested case hearing on issues the requestor submitted in their timely comments that were not subsequently withdrawn. If a hearing is granted, the subject of a hearing will be limited to disputed issues of fact or mixed questions of fact and law relating to relevant and material air quality concerns submitted during the comment period. Issues such as property values, noise, traffic safety, and zoning are outside of the Commission's jurisdiction to address in this proceeding.




General Site Description:




Existing and Newly Acquired Land - Aerial View

Knife River Corporation - South Process Description

Crushing Facility Operation:

Material is front end loaded to the jaw crusher (primary). From the jaw crusher, the fines are conveyed and stockpiled. Larger material will be conveyed to the screening unit where it will be sized and stockpiled. Oversized material will be conveyed to the HSI crusher (secondary).


Once crushed to desired size, material will be conveyed to scalper screen 1. Smaller material will be stockpiled. Larger material will be conveyed to the VSI crusher (tertiary). From VSI, material will be conveyed to scalper screen 2. Material will be sized and conveyed to either the sand screw, then stockpiled or conveyed to the wash plants.

Wash plants consist of coarse and fine plants. Based on size, material will be conveyed from scalper 2 to applicable wash plant. Once processed through wash plant, material will be conveyed to screening unit 2. At this point, all material is saturated.

Water will be used to control dust as necessary from all emission points including stockpiles. Roads will be watered as necessary to control dust emissions.

Please note, process description may vary based on desired product – pieces of equipment may or may not operate all at the same time. Description provided above includes all authorized equipment under 283J.

Knife River Corporation - South BACT / NSPS / MSS / PSD

Best Available Control Technology:

KRC-S follows Best Available Control Technology (BACT) guidelines as defined by the TCEQ Mechanical Sources – Rock Crushing Facilities (NSPS – Subpart OOO), last revised in January 2021, to minimize dust (PM, PM10 and PM2.5) emissions from the concrete crushing plant. Permanently mounted spray bars will be installed at the inlet and outlet of all crushers, at all shaker screens, and at all material transfer points and used as necessary to maintain compliance with all TCEQ rules and regulations.

Roads and stockpiles will be treated with water or chemical suppressant as necessary to reduce emissions.

NSPS, Title 40 CFR Part 60, Subpart OOO:

As required by Special Conditions within the permit, the facility will meet the requirements of 40 CFR Part 60, Subpart OOO and remain within the limits specified within the permit conditions. In accordance with 40 CFR Part 60, Appendix A, Test Method 9 or equivalent, and except for those periods described in 30 TAC §§ 101.201 and 101.211, there will be no more than 7 percent opacity from any transfer point on belt conveyors or from any screen, and no more than 12 percent opacity from any crusher, in accordance with NSPS Subpart OOO. No visible fugitive emissions will leave the property from the crushers, screens, transfer points on belt conveyors, material storage areas, stockpiles, and the internal roads and work areas for a period exceeding 30 seconds in duration in any six-minute period as determined using EPA Test Method 22.

Maintenance, Start-Up, Shut Down:

Based on the nature of the operation of the facility is such that there are no additional emissions generated. The conservatism of the emission calculations covers emissions expected during MSS.

Prevention of Significant Deterioration (PSD):

The site/facility is a minor source and will remain a minor source authorized under the Standard Permit for Permanent Rock Crushers.

All subparagraphs of Texas Commission on Environmental Quality, Regulation VI, Rule 116.111 for construction permits will be addressed to illustrate the feasibility of granting the permit for Knife River Corporation – South.

COMPLIANCE WITH TCEQ REGULATION VI, RULE 116.111(a)(2)

TCEQ Regulation VI, Rule 116.111(a)(2)(A)(i) states: "The emissions from the proposed facility will comply with all rules and regulations of the TCEQ and with the intent of the Texas Clean Air Act, including protection of the health and physical property of the public."

TCEQ Regulation VI, Rule 116.111(a)(2)(A)(ii) states: "For issuance of a permit for construction or modification of any facility within 3,000 feet of an elementary, junior high/middle, or senior high school, the commission shall consider any possible adverse short-term or long-term side effects that an air contaminant or nuisance odor from the facility may have on the individuals attending the school(s)."

Regulation D, IH, IV, V, VII, and XII as they relate to the subject facility are detailed below:

- Reg. II The proposed facility is subject to the Control of Air Pollution from Sulfur Dioxide (S02) requirements of 30 TAC Chapter 112 because the diesel engine / generator set at the site has the potential to emit S02. However, based on previous worst case model results for diesel engines / generator sets associated with rock crushers, the S02 emissions from the diesel engine / generator set will not exceed a net ground level concentration of 0.4 ppm at the property line as indicated in Chapter 112.3.
- Reg. III The proposed facility is not subject to the Hazardous Air Pollutant requirements of 30 TAC Chapter 113 because the facility's emissions do not meet the definition of Hazardous Air Pollutants.
- Reg. IV The proposed facility is not subject to the Control of Air Pollution from Motor Vehicles as required in 30 TAC Chapter 114 because the facility does not meet the definition of a motor vehicle.
- Reg. V The proposed facility is not subject to the Control of Air Pollution from Volatile Organic Compounds (VOCs) requirements of 30 TAC Chapter 115 because the diesel engine / generator set at the site has the potential to emit VOCs; however, the diesel engine / generator set does not relate to any of the Subchapters of Chapter 115.
- Reg. VII The proposed facility is not subject to the Control of Air Pollution from Nitrogen Compounds
 requirements of 30 TAC Chapter 117 because the facility does not relate to acid manufacturing, the
 facility is not a major source of air contaminants, and the facility is not located in the
 Houston/Galveston ozone non-attainment area.

Reg. XII - The proposed facility is not subject to the Federal Operating Permits Program as required
in 30 TAC Chapter 122 because the subject facility's emissions level does not trigger an FOP.

Compliance with the Rules and Regulations of the TCEQ

This application is being submitted in accordance with Chapter 111 pertaining to *Control of Air Pollution from Visible Emissions and Particulate Matter*. Emission calculations in this application are based on the maximum hourly and annual throughput rates. Knife River Corporation - South will comply with the applicable rules of Chapter 111.

The facility is subject to parts of Regulations VI and VIII as detailed below.

This application is being submitted in accordance with Regulation VI (Rule 116) pertaining to *Control of Air Pollution by Permits for New Construction or Modification.* Specific details regarding Regulation VI are noted later in this document.

This application is being submitted in accordance with Regulation VIII (Rule 118) pertaining to *Control of Air Pollution Episodes*. The following air contaminants are subject to Rule 118: Sulfur Dioxide (SO2), Inhalable Particulate Matter (PM10/PM 2.5), Carbon Monoxide (CO), Ozone, and Nitrogen Oxide (NOx). These air contaminants as listed in Chapter 118 may contribute to a Level 1 or Level 2 Air Pollution Episode as determined by the TCEQ. The proposed facility emits PM10/PM2.5, SO2, CO, and NOx. Should an Air Pollution Episode be declared by the TCEQ, this facility will comply with rules of Chapter 118.

Compliance with the Intent of the Texas Clean Air Act (TCAA)

The subject facility will operate in compliance with the intent of the TCAA and will not adversely affect the health and physical property of the general public.

Construction within 3,000 Feet of a School

There are no schools located within 3,000 feet of the facility. The operation of the facility is not expected to result in any short-term or long-term side effects or nuisance odors affecting any individual attending a school facility.

TCEQ Regulation VI, Rule 116.111(a)(2)(B) states: "Measurement of Emissions. The proposed facility will have provisions for measuring the emission of significant air contaminants as determined by the executive director. This may include the installation of sampling ports on exhaust stacks and construction of sampling platforms in accordance with guidelines in the "Texas Natural Resource Conservation Commission (TNRCC) Sampling Procedures Manual."

Knife River Corporation - South will keep records on site that indicate the amount of material processed at the facility on a daily and annual basis. The emissions from this facility can be calculated from these records.

Upon request of the TCEQ or the executive director, the holder of this permit shall perform high volume air sampling for ground level concentrations of particulate matter less than 10 um in diameter (PM10). The tests shall be performed during normal operation of the facilities and shall be performed in accordance with the appropriate EPA test method.

TCEQ Regulation VI, Rule 116.111(a)(2)(C) states: "Best available control technology (BACT). The proposed facility will utilize BACT, with consideration given to the technical practicability and economic reasonableness of reducing or eliminating the emissions from the facility."

BACT will be used by Knife River Corporation - South to control emissions. A review of reasonable and practical pollution control equipment is listed following this section.

TCEQ Regulation VI Rule 116.111(a)(2)(D) states: "New Source Performance Standards (NSPS). The emissions from the proposed facility will meet the requirements of any applicable NSPS as listed under Title 40 Code of Federal Regulations (CFR) Part 60, promulgated by the EPA under FCAA, §111, as amended."

The crushing facility is subject to NSPS Subparts A and OOO. Visible emission testing will be performed as necessary in accordance with 40 CFR Part 60 Subparts A and OOO.

TCEQ Regulation VI, Rule 116.111(a)(2)(E) states: "National Emission Standards for Hazardous Air Pollutants (NESHAP). The emissions from the proposed facility will meet the requirements of any applicable NESHAP, as listed under 40 CFR Part 61, promulgated by EPA under FCAA, §112, as amended."

There are no applicable NESHAP requirements listed in 40 CFR Part 61, promulgated by the EPA under FCAA§112, as amended, for this facility.

TCEQ Regulation VI, Rule 116.111(a)(2)(F) states: "NESHAP for source categories. The emissions from the proposed facility will meet the requirements of any applicable maximum achievable control technology standard as listed under 40 CFR Part 63, promulgated by the EPA under FCAA, 112 or as listed under Chapter 113, Subchapter C of this title (relating to National Emissions Standards for Hazardous Air Pollutants for Source Categories (FCAA 112, 40 CFR 63)."

These rules do not apply to this facility since it is not a major source of Hazardous Air Pollutants.

TCEQ Regulation VI, Rule 116.111(a)(2)(G) states: "Performance demonstration. The proposed facility will achieve the performance specified in the permit application. The applicant may be required to submit additional engineering data after a permit has been issued in order to demonstrate further that the proposed facility will

achieve the performance specified in the permit application. In addition, dispersion modeling, monitoring, or stack testing may be required."

Knife River Corporation - South will meet the performance criteria represented in this application. Additional information will be submitted, if requested by the Executive Director, to further demonstrate that the proposed facility will achieve the performance specified in the application.

TCEQ Regulation VI, Rule 116.111(a)(2)(H) states: "Non-attainment review. If the proposed facility is located in a non-attainment area, it shall comply with all applicable requirements in this chapter concerning non-attainment review."

The proposed facility is portable and could conceivably relocate to a non-attainment area. However, the facility's maximum annual permitted emissions will not exceed the major source threshold in any listed non-attainment area of the State of Texas at the time of tins application submittal.

TCEQ Regulation VI, Rule 116.111(a)(2)(I) states: "Prevention of Significant Deterioration (PSD) review. If the proposed facility is located in an attainment area, it shall comply with all applicable requirements in this chapter concerning PSD review."

The facility is not a major source of air contaminant emissions and does not contribute to significant deterioration of air quality; therefore, no PSD application is required.

TCEQ Regulation VI, Rule 116.111(a)(2)(J) states: "Air dispersion modeling. Computerized air dispersion modeling may be required by the executive director to determine air quality impacts from a proposed new facility or source modification. In determining whether to issue, or in conducting a review of, a permit application for a shipbuilding or ship repair operation, the commission will not require and may not consider air dispersion modeling results predicting ambient concentrations of non-criteria air contaminants over coastal waters of the state. The commission shall determine compliance with noncriteria ambient air contaminant standards and guidelines at land-based off-property locations."

If required, the facility will undertake computerized air dispersion modeling to document compliance.

TCEQ Regulation VI, Rule 116.111(a)(2)(K) states: "Hazardous air pollutants. Affected sources (as defined in §116.15(1) of this title (relating to Section 112(g) Definitions) for hazardous air pollutants shall comply with all applicable requirements under Subchapter C of this chapter (relating to Hazardous Air Pollutants: Regulations Governing Constructed or Reconstructed Major Sources (FCAA, §112(g), 40 CFR Part 63)."

The subject facility is not a source for hazardous air pollutants; therefore this rule does not apply to this facility.

TCEQ Regulation VI, Rule 116.111(a)(2)(L) states: "Mass cap and trade allowances. If subject to Chapter 101,

Subchapter H, Division 3, of this title (relating to Mass Emissions Cap and Trade Program), the proposed facility, group of facilities, or account must obtain allowances to operate."

The subject facility is not subject to Chapter 101, Subchapter H, Division 3 because this facility is not proposed to be located in the Houston/Galveston ozone non-attainment area as defined in § 101.1.

EMISSION CONTROLS AND BACT SELECTION:

Knife River Corporation - South will utilize Best Available Control Technology (BACT) at the proposed facility. Permanently mounted spray bars shall be installed at the inlet/outlet of all crushers, at all shaker screens, and at all material transfer points and used as necessary to maintain compliance with TCEQ rules and regulations. In-plant roads and traffic areas, active work areas, and stockpiles shall be sprinkled with water and/or environmentally-sensitive chemicals as necessary to minimize dust emissions.

This is in response to your letter received May 10, 2018 and your Form PI-1 (General Application for Air Preconstruction Permits and Amendments) concerning the proposed amendment to Permit Number 283J. We understand that you propose to add new equipment consisting of a vertical shaft impact crusher, 2 scalping screens, a sand screw, a wash screen and a double deck screening unit. In addition to incorporating the new equipment, we understand that you wish to alter special condition 11. E.1. to reference the distance limitation requirement of the facility to reflect a 265-foot property line distance limitation. Also, this will acknowledge that your application for the above-referenced amendment is technically complete as of December 20, 2018.

In accordance with Title 30 Texas Administrative Code (TAC) §116.116(b) and §116.160 and based on our review, Permit Number 283J is hereby amended. This information will be incorporated into the existing permit file. Enclosed are revised general conditions (permit face), special conditions, and a maximum allowable emission rates table. We appreciate your careful review of the special conditions of the permit and assuring that all requirements are consistently met.

This amendment will be automatically void upon the occurrence of any of the following, as indicated in 30 TAC §116.120(a):

- Failure to begin construction of the changes authorized by this amendment within 18 months from the date of this authorization.
- 2. Discontinuance of construction of the changes authorized by this amendment for a period of 18 consecutive months or more.
- 3. Failure to complete the changes authorized by this amendment within a reasonable time.

Upon request, the executive director may grant extensions as allowed in 30 TAC §116.120(b).

You may file a **motion to overturn** with the Chief Clerk. A motion to overturn is a request for the commission to review the executive director's decision. Any motion must explain why the commission

should review the executive director's decision. According to 30 TAC §50.139, an action by the executive director is not affected by a motion to overturn filed under this section unless expressly ordered by the commission.

A motion to overturn must be received by the Chief Clerk within 23 days after the date of this letter. An original and 7 copies of a motion must be filed with the Chief Clerk in person, or by mail to the Chief Clerk's address on the attached mailing list. On the same day the motion is transmitted to the Chief Clerk, please provide copies to the applicant, the executive director's attorney, and the Public Interest Counsel at the addresses listed on the attached mailing list. If a motion to overturn is not acted on by the commission within 45 days after the date of this letter, then the motion shall be deemed overruled.

You may also request **judicial review** of the executive director's approval. According to Texas Health and Safety Code §382.032, a person affected by the executive director's approval must file a petition appealing the executive director's approval in Travis County district court within 30 days after the **effective date of the approval**. Even if you request judicial review, you still must exhaust your administrative remedies, which includes filing a motion to overturn in accordance with the previous paragraphs.

You are reminded that these facilities must be in compliance with all rules and regulations of the Texas Commission on Environmental Quality (TCEQ) and of the U.S. Environmental Protection Agency at all times.

For the Commission

- 1. **Facilities** covered by this permit shall be constructed and operated as specified in the application for the permit. All representations regarding construction plans and operation procedures contained in the permit application shall be conditions upon which the permit is issued. Variations from these representations shall be unlawful unless the permit holder first makes application to the Texas Commission on Environmental Quality (commission) Executive Director to amend this permit in that regard and such amendment is approved. [Title 30 Texas Administrative Code (TAC) Section 116.116 (30 TAC § 116.116)] ¹
- 2. **Voiding of Permit**. A permit or permit amendment is automatically void if the holder fails to begin construction within 18 months of the date of issuance, discontinues construction for more than 18 months prior to completion, or fails to complete construction within a reasonable time. Upon request, the executive director may grant an 18-month extension. Before the extension is granted the permit may be subject to revision based on best available control technology, lowest achievable emission rate, and netting or offsets as applicable. One additional extension of up to 18 months may be granted if the permit holder demonstrates that emissions from the facility will comply with all rules and regulations of the commission, the intent of the Texas Clean Air Act (TCAA), including protection of the public's health and physical property; and (b)(1)the permit holder is a party to litigation not of the permit holder's initiation regarding the issuance of the permit; or (b)(2) the permit holder has spent, or committed to spend, at least 10 percent of the estimated total cost of the project up to a maximum of \$5 million. A permit holder granted an extension under subsection (b)(1) of this section may receive one subsequent extension if the permit holder meets the conditions of subsection (b)(2) of this section. [30 TAC § 116.120]
- 3. **Construction Progress**. Start of construction, construction interruptions exceeding 45 days, and completion of construction shall be reported to the appropriate regional office of the commission not later than 15 working days after occurrence of the event. [30 TAC § 116.115(b)(2)(A)]
- 4. **Start-up Notification**. The appropriate air program regional office shall be notified prior to the commencement of operations of the facilities authorized by the permit in such a manner that a representative of the commission may be present. The permit holder shall provide a separate notification for the commencement of operations for each unit of phased construction, which may involve a series of units commencing operations at different times. Prior to operation of the facilities authorized by the permit, the permit holder shall identify the source or sources of allowances to be utilized for compliance with Chapter 101, Subchapter H, Division 3 of this title (relating to Mass Emissions Cap and Trade Program). [30 TAC § 116.115(b)(2)(B)]
- 5. **Sampling Requirements**. If sampling is required, the permit holder shall contact the commission's Office of Compliance and Enforcement prior to sampling to obtain the proper data forms and procedures. All sampling and testing procedures must be approved by the executive director and coordinated with the regional representatives of the commission. The permit holder is also responsible for providing sampling facilities and conducting the sampling operations or contracting with an independent sampling consultant. [30 TAC § 116.115(b)(2)(C)]
- 6. **Equivalency of Methods.** The permit holder must demonstrate or otherwise justify the equivalency of emission control methods, sampling or other emission testing methods, and monitoring methods proposed as alternatives to methods indicated in the conditions of the permit. Alternative methods shall be applied for in writing and must be reviewed and approved by the executive director prior to their use in fulfilling any requirements of the permit. [30 TAC § 116.115(b)(2)(D)]
- 7. **Recordkeeping.** The permit holder shall maintain a copy of the permit along with records containing the information and data sufficient to demonstrate compliance with the permit, including production records and

operating hours; keep all required records in a file at the plant site. If, however, the facility normally operates unattended, records shall be maintained at the nearest staffed location within Texas specified in the application; make the records available at the request of personnel from the commission or any air pollution control program having jurisdiction in a timely manner; comply with any additional recordkeeping requirements specified in special conditions in the permit; and retain information in the file for at least two years following the date that the information or data is obtained. [30 TAC § 116.115(b)(2)(E)]

- 9. **Maintenance of Emission Control**. The permitted facilities shall not be operated unless all air pollution emission capture and abatement equipment is maintained in good working order and operating properly during normal facility operations. The permit holder shall provide notification in accordance with 30 TAC §101.201, 101.211, and 101.221 of this title (relating to Emissions Event Reporting and Recordkeeping Requirements; Scheduled Maintenance, Startup, and Shutdown Reporting and Recordkeeping Requirements; and Operational Requirements). [30 TAC§ 116.115(b)(2)(G)]
- 10. **Compliance with Rules**. Acceptance of a permit by an applicant constitutes an acknowledgment and agreement that the permit holder will comply with all rules and orders of the commission issued in conformity with the TCAA and the conditions precedent to the granting of the permit. If more than one state or federal rule or regulation or permit condition is applicable, the most stringent limit or condition shall govern and be the standard by which compliance shall be demonstrated. Acceptance includes consent to the entrance of commission employees and agents into the permitted premises at reasonable times to investigate conditions relating to the emission or concentration of air contaminants, including compliance with the permit. [30 TAC § 116.115(b)(2)(H)]
- 11. **This** permit may not be transferred, assigned, or conveyed by the holder except as provided by rule. [30 TAC § 116.110(e)]
- 12. **There** may be additional special conditions attached to a permit upon issuance or modification of the permit. Such conditions in a permit may be more restrictive than the requirements of Title 30 of the Texas Administrative Code. [30 TAC § 116.115(c)]
- 13. **Emissions** from this facility must not cause or contribute to "air pollution" as defined in Texas Health and Safety Code (THSC) §382.003(3) or violate THSC § 382.085. If the executive director determines that such a condition or violation occurs, the holder shall implement additional abatement measures as necessary to control or prevent the condition or violation.
- 14. **The** permit holder shall comply with all the requirements of this permit. Emissions that exceed the limits of this permit are not authorized and are violations of this permit. ¹

Emission Limitations

1. This permit authorizes only those sources of emissions listed in the attached table entitled "Emission Sources - Maximum Allowable Emission Rates," and those sources are limited to the emission limits and other conditions specified in the table. In addition, this permit authorizes all emissions from planned startup and shutdown activities associated with facilities or groups of facilities that are authorized by this permit.

Federal Applicability

- 2. These facilities shall comply with all applicable requirements of the U.S. Environmental Protection Agency (EPA) Regulations on Standards of Performance for New Stationary Sources (NSPS) promulgated in Title 40 Code of Federal Regulations (40 CFR) Part 60, specifically the following:
- A. Subpart A General Provisions;
- B. Subpart OOO Nonmetallic Mineral Processing Plants; and

Opacity/Visible Emission Limitations

- 3. Visible fugitive emissions shall not leave the property for more than 30 cumulative seconds in any six-minute period.
- 4. In accordance with 40 CFR Part 60, Appendix A, Test Method 9 or equivalent, and except for those periods described in 30 Texas Administrative Code (30 TAC) § 101.201 and § 101.211, opacity of emissions from any transfer point on belt conveyors or from any screen shall not exceed 7 percent and from any crusher shall not exceed 12 percent for facilities (as defined in 40 CFR §§ 60.670 and 60.671) that commence construction, modification, or reconstruction on or after April 22, 2008. Opacity of emissions from any transfer point on belt conveyors or from any screen shall not exceed 10 percent and from any crusher shall not exceed 15 percent for facilities (as defined in 40 CFR §§ 60.670 and 60.671) that commenced construction, modification, or reconstruction after August 31, 1983 but before April 22, 2008. The opacity of emissions shall not exceed the indicated percent averaged over a six-minute period. (1/19)

Operational Limitations, Work Practices, and Plant Design

5. The facility shall be limited to the following hourly and annual throughput rates: (1/19)

- 6. The facilities are authorized to operate up to 8,760 hours per year.
- 7. Spray bars shall be installed at the inlet and outlet of all crushers, at all shaker screens, at the truck unloading hopper, and at all material transfer points. A dedicated water truck or area-type water sprays shall be available or installed at all stockpiles and active work areas. All water spray systems shall be operated as necessary to maintain compliance with TCEQ rules and regulations.
- 8. Crushers (Emission Point Nos. [EPNs] 1 and 3) and the Screen (EPN 2) will incorporate partial covers which will be in place during any crushing and screening operations. (1/19)
- 9. All in-plant roads and traffic areas, active work areas, and aggregate stockpiles shall be sprayed with water with an installed area type water spray or a dedicated truck upon detection of visible particulate matter emissions to maintain compliance with all applicable TCEQ rules and regulations. Care will be taken to prevent oversaturated conditions which would cause outgoing trucks to track mud onto public streets. Days in which rainfall exceeds 0.1 inch shall be counted as water sprinkled.
- 10. All stationary equipment authorized by this permit shall be prominently marked to show the assigned TCEQ regulated entity number or permit number, excluding the location suffix (example: L001). These markings must be clearly visible. These identification markings shall be removed from the equipment when it is no longer authorized by the TCEQ.

Movement of a Portable Facility

- 11. The following are requirements for movement of this portable facility:
- A. Prior to moving permitted facilities or sources to any new site (even if authorization for the site has previously been granted), the holder of the permit shall request relocation or change of location authorization and obtain written approval from the TCEQ Executive Director or designated representative. Additionally, once construction has begun at any site, the applicant shall notify the appropriate TCEQ Regional Office and local air pollution control programs in writing of the actual dates of start of construction and operation.
- B. The appropriate TCEQ Regional Office may approve the following types of relocations:
 - A permitted facility and associated equipment to be located temporarily* in the right-ofway, or contiguous to the right-of-way, of a public works project, or
 - *Note: A temporary facility is one that occupies a designated site for not more than 180 consecutive days or supplies materials for a single project (single contract or same contractor for related project segments, but not other unrelated projects.)
 - (2) A portable facility moving to a site in which a portable facility has been located at the site at any time during the previous two years and public notice was accomplished at the site as required under 30 TAC Chapter 39 (relating to Public Notice).
- C. If the holder of the permit meets either 11.B.(1) or 11.B.(2) above, the permit holder shall submit a complete written request to the TCEQ Regional Office for the new location and obtain written approval before the start of construction and commencement of operations at the new site. The permit holder is responsible for providing proof of submittal for all

relocation requests. Construction may begin after receipt of approval from the appropriate TCEQ Regional Office or 12 business days after the date of postmark or the date of personal delivery of the request, whichever occurs first, unless disapproval is sent within the 12 business days. The permit holder's request is considered approved if the appropriate TCEQ Regional Office does not provide approval or denial of a complete submittal within 12 business days; however, the presumed approval does not exempt the applicant from ensuring that public notice was accomplished at the new site as required under 30 TAC Chapter 39. The relocation request shall contain all of the following information:

- (1) The company name, address, company contact, and telephone number;
- (2) A copy of the existing permit conditions and the maximum allowable emission rates table that are in effect for the permitted facility;
- (3) The regulated entity number (RN), customer reference number (CN), applicable permit or registration numbers and, if available, TCEQ account number;
- (4) The location from which the facility is moving (current location);
- (5) A location description of the proposed site (city, county, and exact physical location description);
- (6) A scaled plot plan that identifies the location of all equipment and stockpiles, and also indicates that the required distances to the property lines can be met;
- (7) A scaled area map that identifies the distance and direction to the closest off-property receptor (if required) and clearly indicates how the proposed site is contiguous or adjacent to the right-of-way of a public works project (if required);
- (8) The proposed date for start of construction and expected date for start of operation;
- (9) The expected time period at the proposed site;
- (10) The permit or registration number of the portable facility that was located at the proposed site any time during the last two years, and the date the facility was last located there. This information is not necessary if the relocation request is for a public works project that is contiguous or in the right-of-way of a public works project; and
- (11) Proof that the proposed site had accomplished public notice, as required by 30 TAC Chapter 39. This proof is not necessary if the relocation request is for a public works project that is contiguous or adjacent to the right-of-way of a public works project.
- D. To move a permitted facility and associated equipment to a site that does not meet either 11.B.(1) or 11.B.(2), the holder of this permit shall submit a change of location request to the TCEQ Air Permits Division, Air Permits Initial Review Team, MC-161, P.O. Box 13087, Austin, Texas 78711-3087 using Form PI-1, along with all supporting documents. In accordance with the Texas Health and Safety Code § 382.056, the applicant may be required to publish public notice prior to being authorized for a change of location to a new site.
- E. All relocation and change of location applications shall comply with the following conditions:
 - (1) The rock crushing facility and all associated sources (screens, transfer points on belt conveyors, feed bins, and work areas that are only associated with the facility) shall be located a minimum of 265 feet from the property line and a minimum of 550 feet from another rock crushing facility, concrete batch plant, or hot mix asphalt plant. If this distance of 550 feet cannot be met, then this crushing plant will not operate at the same time as another crushing plant, concrete batch plant, or asphalt plant on-site within this distance. (1/19)

- (2) Any rock crusher that is crushing concrete shall be located a minimum of 440 yards (1/4 mile) from any single or multifamily residence, school, or place of worship, unless the crusher is:
 - (a) at a location authorized for crushing concrete on or prior to September 1, 2001;
 - at a location that satisfies this distance requirement at the time the initial application is filed with the TCEQ, and a single or multifamily residence, school, or place of worship is subsequently built or put to use within 440 yards of the facility; or
 - (c) engaged, for not more than 180 days, in crushing concrete produced by the demolition of a structure at the location of the structure and the concrete is being crushed primarily for use at that location.
- (3) Stockpiles, in-plant roads, and traffic areas (except for entrance and exit to the site) shall be located a minimum of 25 feet from any property line. In lieu of meeting the distance requirements for roads and stockpiles, the following must occur:
 - (a) Roads and other traffic areas within the buffer distance must be bordered by dust-suppressing fencing or other dust-suppressing barrier along all traffic routes or work areas. These borders shall be constructed to a height of at least 12 feet; and
 - (b) Stockpiles within this buffer distance must be contained within a three-walled bunker that extends at least two feet above the top of the stockpile.

Demonstration of Continuous Compliance

- 12. Upon request of the Executive Director of the TCEQ, the holder of this permit will perform high volume air sampling, one and/or three-hour tests, for net ground level concentrations of total particulate matter. Each test will consist of one upwind and one downwind sample taken simultaneously. The test(s) will be performed during normal operation of the facilities. High volume sampling shall be performed in accordance with Chapter 11 (PM) of the TCEQ Sampling Procedures Manual.
- 13. The holder of this permit shall conduct a quarterly visible fugitive emissions determination to demonstrate compliance with the visible fugitive emissions limitation specified in this permit. This visible fugitive emissions determination shall be performed: 1) during normal plant operations, 2) for a minimum of six minutes, 3) approximately perpendicular to plume direction, 4) with the sun behind the observer (to the extent practicable), 5) at least 15 feet, but not more than 0.25 mile, from the plume, and 6) in accordance with EPA 40 CFR Part 60, Appendix A, Test Method 22, except where stated otherwise in this condition. If visible fugitive emissions leaving the property exceed 30 cumulative seconds in any six-minute period, the owner or operator shall take immediate action (as appropriate) to eliminate the excessive visible fugitive emissions. The corrective action shall be documented within 24 business hours of completion. (1/19)

Recordkeeping Requirements

14. In addition to the recordkeeping requirements specified in General Condition No. 7 and 40 CFR Part 60, Subparts A and OOO, the following records shall be maintained at this facility site and made available at the request of personnel from the TCEQ or any other air pollution control program having jurisdiction to demonstrate compliance with permit limitations. These records shall
