System Interconnects:

TROT ACE Process:

In April, TROT began a new process for exception reviews called the ACE Process (Administratively Complete Evaluation). This new process determines if submittals are administratively deficient within one business day of receipt, and the customer is notified to provide more information to proceed with the technical review of their request. This process is improving the way TROT provides customer service by administering feedback soon after their submittal is received, and providing the customer with direct contact to the TROT reviewer for any questions.

TROT Launches New-and-Improved Filter Backwash Recycling Rule Webpage

In October, TROT updated the TCEQ's Filter Backwash Recycling Rule webpage. All public water system treatment plants that use surface water or groundwater under the direct influence of surface water (GUI) must submit a Water Treatment Plant Recycling Practices Report (RPR) and treatment plant schematic. The webpage provides information about how to complete the report and submit it to the TCEQ. This documentation ensures that recycled streams are adequately controlled by minimizing interference with the treatment process. Capacity Development:

- The next Texas Water Infrastructure Coordination Committee (TWICC) is tentatively scheduled for Thursday, December 14th and will be hosted by the Texas Water Development Board. For questions, please contact Dorothy Young at (512) 239-6064 or Tom Entsminger at TWDB at (512) 936-0802. Since Hurricane Harvey, FEMA, TDEM and GLO have attended TWICC meetings to Provide Harvey funding updates along with the regular TWICC members.

Texas Optimization Program:

- In FY 2017, TOP staff took part in three public drinking water recognition events, one special performance evaluation, five mandatory comprehensive evaluations, and six training activities throughout Texas.
- TOP staff also performed 21 Revised Total Coliform Rule (RTCR) level 2 assessments.
- Additionally, TOP staff performed numerous technical assistance activities throughout the state, including those related to Hurricane Harvey.

Drought:

- The consistent precipitation has continued to provide drought relief
- Staff continue to monitor 18 systems, and have moved four systems from High Priority and Watch Lists to the Resolved List since July 2017.

Assistance for At-Risk Public Water Systems:

- Staff continue to monitor approximately 110 systems designated as "At Risk," including systems under Temporary Management and Receivership.
- Staff were able to remove one system from the At-Risk List, since July 2017.

Cross-Connection Control:

- TCEQ Cross-Connection Control Program staff traveled to El Paso to evaluate the presentation of Directed Assistance Module No. 12 (DAM 12). This DAM is titled “How to Develop and Manage an Effective Cross-Connection Control Program (CCCP)” and was presented to several regional public water systems as well as TCEQ Region 6 staff. DAM 12 was well received and the water system representatives expressed their appreciation for the important knowledge they gained.
- Cross-Connection Control Program staff developed guidance for water systems that were impacted by Hurricane Harvey. At issue was the inundation of backflow prevention assemblies and the effect this has on them functioning properly. This guidance provided information on how to address these assemblies and the risk of contamination of the water supply.
- The Backflow Prevention Assembly Test & Maintenance Report and the Customer Service Inspection Certificate were both updated by program staff. The changes will make the information documented on these forms more meaningful to water systems as well as to the testers and inspectors using them. Source Water Assessment & Protection (SWAP) / Source Water Protection (SWP)

- TCEQ DWIP Team manages the SWP contract. The contract is in the Request for Proposal stage and hope to have a contractor in place by 2018.
- TCEQ DWIP Team assists Texas Rural Water Association as they continue to implement SWP projects for public water systems throughout the state by providing SWP area maps and GPS technical assistance.
- TCEQ DWIP Team assists the Plan and Technical Review Section with the Texas Optimization Program and Texas Optimization Program Recognition Program.
 - Water Treatment Plants receiving 6 month certificates during June, July and August were: Aquilla WSD, Bluebonnet WSC, Dallas-East Side, Dallas-Elm Fork, Lewisville, North Texas MWD Wylie-Plant IV, Waco-Mt. Carmel, Waco-Riverside and Waxahachie-Howard.
 - 16 surface water treatment plants participating in Recognition Program, currently two have met all the requirements continuously for more than five years, two for more than ten years, and one for more than 15 years.
 - In August TPWD-Guadalupe River State Park joined the Recognition Program
 - In September TCEQ presented the City of Dallas – Bachman Plant with a 10 year plaque. Bachman has met all the Recognition Program requirements continuously from November 2006 to September 2017.
 - In September TCEQ presented the City of Houston SE Water Purification Plant with a one year flag. Southeast has met all the Recognition Program requirements continuously from May 2016 to July 2017.
 - In October TCEQ presented the Benbrook Water Authority with a 10 year plaque. Benbrook has met all the Recognition Program requirements continuously from May 2007 to September 2017.
