Plan Review Team (PRT):

Number of plans and specifications submittals processed by the Plan Review Team during October - December: 581

PRT is working on a staff guidance document for chemical mixing requirements and new checklists for surface water treatment (WST) plants. Review of new SWT plants and significant upgrades to existing plants is moving to a two-step process, like that for wells and reverse osmosis. The staff guidance document on mixing of chlorine and ammonia on chloramine submittals is to assist with determining compliance with Section $290.42 \in (7)$ (B) "Mixing shall be provided to disperse chemicals."

System Interconnects:

PRT has created a new checklist which provides an outline of the information required to be submitted for both Emergency Interconnections and Purchase Water Interconnections. Information required to be submitted includes the physical piping connection, chemical analysis for compatibility, and the management requirements such as contracts, rates, and terms of service. Capacity Development:

 The Texas Water Infrastructure Coordination Committee (TWICC) meeting that was scheduled for December was held at the Texas Water Development Board on January 19, 2018. Texas Optimization Program:

- In the 4th quarter of FY 2017, TOP staff took part in one public drinking water recognition event.
- TOP staff also performed nine Revised Total Coliform Rule (RTCR) level 2 assessments.
- Additionally, TOP staff performed five technical assistance activities throughout the state, and two all staff training events.

Drought:

• Drought has returned to the state. Approximately 37% of the state is in moderate drought and approximately 11% of the state is in severe drought with small pockets of extreme

- drought. Drought is predicted to persist and possibly intensify in the panhandle and northern part of the state as well as the hill country. Drought removal is predicted in the eastern part of the state.
- Staff continue to monitor 14 systems, and have moved four systems from High Priority and Watch Lists to the Resolved List since October 2017.

Assistance for At-Risk Public Water Systems:

- Staff continue to monitor 9 systems in receivership, 7 systems under temporary management and 63 systems designated as "At Risk."
- Staff were able to remove six systems from the At-Risk List, since September 2017.

Cross-Connection Control:

- Staff in the TCEQ Cross-Connection Control Program are assisting the Office of Compliance and Enforcement Program Support Section with a rule petition they are processing. The Cross-Connection Control program attended stakeholder meetings in Fort Worth and Houston and provided a presentation on the basics of backflow prevention.
- The Cross-Connection Control Program continues to assist Public Water Systems and TCEQ regional investigators with their many questions and issues in protecting the potable water supply from backflow. Staff receive phone calls and emails on issues like record keeping, inspections, lead in the plumbing, enforcement, and education.
- This program has also assisted in providing Directed Assistance Module 12, <u>How to Develop and Manage an Effective Cross-Connection Control Program</u>, to water systems. This is free on-site assistance offered to water systems.
