<b>PWS to fill out the following fields. This form may be used for both lead &amp; copper tap and/or source sampling as required.</b>	
<b>PWS Name:</b>	Name of the Public water system
<b>PWS ID:</b>	Public water system identification number (seven digits preceded by the letters "TX")
<b>PWS Address:</b>	Public water system address
<b>PWS Contact Name:</b>	PWS contact person (or agent) responsible for the samples
<b>PWS Contact Phone:</b>	PWS contact (or agent) phone number
<b>PWS Tap Sample Checklist (√):</b>	Complete the checklist for lead & copper tap sampling. Samples must be delivered to the lab within 14 24-hour periods. Not all items on the Checklist are applicable to source water lead/copper samples.
<b>Sample Type - Compliance or Non-compliance (√):</b>	Check whether samples are to be used for compliance or not.
<b>Sample collection acknowledgement:</b>	Responsible PWS representative (or agent) who vouches for correct sample collection procedure and documentation. Fill out name, signature, organization, and date. Individual directly responsible for the collection of samples must ensure correct sample collection by checking all six items under the PWS Tap Sample Checklist.
<b>Facility ID #:</b>	Facility ID number found in Texas Drinking Water Watch (DWW). DS01 for distribution, PBCU001, etc. for entry points. Refer to "Sample Points" link on the Texas DWW Webpage: < <a href="http://dww2.tceq.texas.gov/DWW/">http://dww2.tceq.texas.gov/DWW/</a> >
<b>Sample Point ID #:</b>	Sample point ID number found in Texas Drinking Water Watch (e.g. LCR001, ELCR, etc.). Refer to "Sample Points" link on the Texas DWW Webpage: < <a href="http://dww2.tceq.texas.gov/DWW/">http://dww2.tceq.texas.gov/DWW/</a> >
<b>Sample Location:</b>	Address and sink type—found in Texas Drinking Water Watch under Sample Points; example-123 Main Street, kitchen sink for First Draw Samples or location of entry point for non-first draw samples.
<b>Sample Faucet Last Used Date:</b>	The date water was last used at sink in MM/DD/YY format
<b>Sample Faucet Last Used Time:</b>	The time water was last used at sink in 24 hour HH:MM format
<b>Sample Collected Date:</b>	The date of sample collection by PWS or homeowner in MM/DD/YY format.
<b>Sample Collected Time:</b>	The time of sample collection by PWS or homeowner in 24 hour HH:MM format.
<b>Replacement (√):</b>	Check (√) if the sample replaces a previously rejected sample. Otherwise, leave blank.
<b>Original Sample ID:</b>	If the "Replacement Indicator" box is checked fill out the "Original Sample ID #" column". Otherwise leave blank. (Can be added by the laboratory)
<b>Original Collection Date:</b>	If the "Replacement Indicator" box is checked fill out the "Original Sample Collection Date" column. Otherwise leave blank. (Can be added by the laboratory)
<b>Chain of Custody (COC):</b>	Indicate transfer by signature, date and time if the form is used to document COC. Several lines are provided for multiple transfers.
<b>Laboratory to fill out the following fields. <b>Laboratory Name:</b>	Laboratory name
<b>Laboratory Address:</b>	Laboratory's address
<b>TCEQ Laboratory ID #:</b>	Laboratory ID number, unique to the Safe Drinking Water Act Information System (SDWIS). Usually the first ten digits of the accreditation ID
<b>Laboratory Contact Name:</b>	Laboratory contact name (for questions regarding analysis)
<b>Laboratory Contact Phone #:</b>	Laboratory contact phone number
<b>Samples delivered unpreserved (Y or N):</b>	Indicate "Y" if samples were received unpreserved. Indicate "N" if samples received preserved; reject samples and use rejection code "PR."
<b>Samples collected in 1-L labeled bottles (Y or N):</b>	Indicate "Y" if samples were received in properly labelled, 1 liter containers. Otherwise, indicate "N"; reject samples and use rejection code "IC."
<b>Samples filled to 1-L fill line (Y or N):</b>	Indicate "Y" if samples were correctly filled to the 1 liter fill line. Otherwise, indicate "N"; reject samples and use rejection code "EV" for excessive volume or "VO" for insufficient volume.
<b>Actual sample temperature:</b>	Record uncorrected temperature upon arrival at the laboratory.
<b>Corrected temperature:</b>	Record corrected temperature upon arrival at the laboratory
<b>Thermometer ID #:</b>	Record the serial number or other unique identifier of thermometer used to measure temperature.
<b>Lab Sample ID:</b>	Laboratory generated sample identifier
<b>Lab Preservation Date:</b>	Date the lab preserved the sample in MM/DD/YY format.
<b>Lab Preservation Time:</b>	Time the lab preserved the sample in HH:MM format.
<b>Sample Rejection Code:</b>	Enter a sample rejection code if applicable. Additional information can be included in laboratory comments. See QAPP Addendum 2 for a list of rejection codes.
<b>Received by Lab:</b>	Indicate receipt of samples by providing signature and date of sample arrival at lab.
